3.10 \$388,000 the first year and \$388,000 the
 3.11 second year are from the remediation fund
 3.12 for administrative funding for the voluntary
 3.13 cleanup program.

3.14 \$75,000 the first year and \$75,000 the second
 3.15 year are for compensation for destroyed or
 3.16 crippled animals under Minnesota Statutes,
 3.17 section 3.737. If the amount in the first year
 3.18 is insufficient, the amount in the second year
 3.19 is available in the first year.

3.20 \$75,000 the first year and \$75,000 the second
 3.21 year are for compensation for crop damage
 3.22 under Minnesota Statutes, section 3.7371. If
 3.23 the amount in the first year is insufficient, the
 3.24 amount in the second year is available in the
 3.25 first year.

3.26 If the commissioner determines that claims
 3.27 made under Minnesota Statutes, section
 3.28 3.737 or 3.7371, are unusually high, amounts
 3.29 appropriated for either program may be
 3.30 transferred to the appropriation for the other
 3.31 program.

4.1 \$100,000 the first year and \$100,000 the
4.2 second year are for plant pest surveys.
4.3 \$50,000 in the first year is for additional
4.4 duties under the noxious weed law changes in
4.5 this article. This is a onetime appropriation.

4.8 \$186,000 the first year and \$186,000 the
4.9 second year are for transfer to the Minnesota
4.10 grown account and may be used as grants
4.11 for Minnesota grown promotion under
4.12 Minnesota Statutes, section 17.102. Grants
4.13 may be made for one year. Notwithstanding
4.14 Minnesota Statutes, section 16A.28, the
4.15 appropriations encumbered under contract on
4.16 or before June 30, 2011, for Minnesota grown
4.17 grants in this paragraph are available until
4.18 June 30, 2013. \$50,000 of the appropriation
4.19 in each year is for efforts that identify
4.20 and promote Minnesota grown products in
4.21 retail food establishments including but not
4.22 limited to restaurants, grocery stores, and
4.23 convenience stores.

4.24 \$100,000 the first year and \$100,000 the
4.25 second year are for grants to farmers for
4.26 demonstration projects involving sustainable
4.27 agriculture as authorized in Minnesota
4.28 Statutes, section 17.116. Of the amount
4.29 for grants, up to \$20,000 may be used for
4.30 dissemination of information about the
4.31 demonstration projects. Notwithstanding
4.32 Minnesota Statutes, section 16A.28, the
4.33 appropriations encumbered under contract
4.34 on or before June 30, 2011, for sustainable

5.1 agriculture grants in this paragraph are
5.2 available until June 30, 2013.

5.3 \$103,000 the first year and \$103,000 the
5.4 second year are to provide training and
5.5 technical assistance to county and town
5.6 officials relating to livestock siting issues
5.7 and local zoning and land use planning,
5.8 including maintenance of the checklist
5.9 template clarifying the federal, state,
5.10 and local government requirements for
5.11 consideration of an animal agriculture
5.12 modernization or expansion project. For the
5.13 training and technical assistance program,
5.14 the commissioner shall continue to seek
5.15 guidance, advice, and support of livestock
5.16 producer organizations, general agricultural
5.17 organizations, local government associations,
5.18 academic institutions, other government
5.19 agencies, and others with expertise in land
5.20 use and agriculture.

5.21 \$77,000 the first year and \$77,000 the second
5.22 year are for integrated pest management
5.23 activities.

5.24 \$10,000 the first year and \$10,000 the
5.25 second year are for annual cost-share

5.29 certification. Annual cost-share payments
5.30 per farmer must be two-thirds of the cost
5.31 of the certification or \$350, whichever is
5.32 less. In any year that a resident farmer or
5.33 person who sells, processes, or packages
5.34 agricultural products in this state receives
5.35 a federal organic certification cost-share

6.1 payment, that resident farmer or person is
 6.2 not eligible for state cost-share payments. A
 6.3 certified farmer is eligible to receive annual
 6.4 certification cost-share payments for up to
 6.5 five years. The commissioner may allocate

 6.22 is a onetime reduction. If the total amount for
 6.23 which all producers are eligible in a quarter
 6.24 exceeds the amount available for payments,
 6.25 the commissioner shall make payments on a
 6.26 pro rata basis. If the appropriation exceeds
 6.27 the total amount for which all producers
 6.28 are eligible in a fiscal year for scheduled
 6.29 payments and for deficiencies in payments
 6.30 during previous fiscal years, the balance
 6.31 in the appropriation is available to the

 7.10 second year are for continuation of the dairy
 7.11 development and profitability enhancement
 7.12 and dairy business planning grant programs
 7.13 established under Laws 1997, chapter
 7.14 216, section 7, subdivision 2, and Laws
 7.15 2001, First Special Session chapter 2,
 7.16 section 9, subdivision 2. The commissioner
 7.17 may allocate the available sums among
 7.18 permissible activities, including efforts to
 7.19 improve the quality of milk produced in the
 7.20 state in the proportions that the commissioner
 7.21 deems most beneficial to Minnesota's dairy

8.23 year are for annual grants to the Minnesota

8.27 improved varieties. The grant recipient may
8.28 subcontract with a qualified third party for
8.29 some or all of the basic and applied research.

8.33 and applied agronomic research on native

9.2 recipient may subcontract with a qualified
9.3 third party for some or all of the basic
9.4 or applied research. The grant recipient
9.5 must actively participate in the Agricultural
9.6 Utilization Research Institute's Renewable
9.7 Energy Roundtable and no later than
9.8 February 1, 2011, must report to the house of
9.9 representatives and senate committees with
9.10 jurisdiction over agriculture finance.

9.11 \$500,000 the first year and \$500,000 the
9.12 second year are for grants to Second Harvest
9.13 Heartland on behalf of Minnesota's six
9.14 Second Harvest food banks for the purchase
9.15 of milk for distribution to Minnesota's food
9.16 shelves and other charitable organizations
9.17 that are eligible to receive food from the food
9.18 banks. Milk purchased under the grants must
9.19 be acquired from Minnesota milk processors
9.20 and based on low-cost bids. The milk must be
9.21 allocated to each Second Harvest food bank
9.22 servicing Minnesota according to the formula
9.23 used in the distribution of United States
9.24 Department of Agriculture commodities
9.25 under The Emergency Food Assistance
9.26 Program (TEFAP). Second Harvest
9.27 Heartland must submit quarterly reports

10.18 balance does not cancel at the end of the first
10.19 year and is available in the second year.

10.34 fertilizer account in the agricultural fund
10.35 for grants for fertilizer research as awarded

11.1 by the Minnesota Agricultural Fertilizer
11.2 Research and Education Council under
11.3 Minnesota Statutes, section 18C.71. The
11.4 amount appropriated in either fiscal year
11.5 must not exceed 57 percent of the inspection
11.6 fee revenue collected under Minnesota

11.8 during the previous fiscal year. No later
11.9 than February 1, 2011, the commissioner
11.10 shall report to the legislative committees

11.14 sentiment of the council concerning the need
11.15 for additional research funds.

11.21 \$30,000 is for star farms program
11.22 development. The commissioner, in
11.23 consultation with other state and local
11.24 agencies, farm groups, conservation groups,
11.25 legislators, and other interested persons, shall
11.26 develop a proposal for a star farms program.
11.27 By January 15, 2010, the commissioner
11.28 shall submit the proposal to the legislative
11.29 committees and divisions with jurisdiction
11.30 over agriculture and environmental policy
11.31 and finance. This is a onetime appropriation.

12.31 Subdivision 1. **Compensation required.** (a) Notwithstanding section 3.736,

12.32 subdivision 3, paragraph (e), or any other law, a livestock owner shall be compensated

13.1 by the commissioner of agriculture for livestock that is destroyed by a gray wolf or is so
13.2 crippled by a gray wolf that it must be destroyed. Except as provided in this section, the
13.3 owner is entitled to the fair market value of the destroyed livestock as determined by the
13.4 commissioner, upon recommendation of a university extension agent or a conservation
13.5 officer. In any fiscal year, a livestock owner may not be compensated for a destroyed
13.6 animal claim that is less than \$100 in value and may be compensated up to \$20,000,
13.7 as determined under this section. In any fiscal year, the commissioner may provide
