BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA: 1.4

Section 1. Minnesota Statutes 2014, section 15A.086, is amended to read: 1.5

15A.086 LIMITS ON BONUS PAYMENTS. 1.6

Subdivision 1. Limits on bonuses for nonprofit corporation employees. 1.7

Notwithstanding any law to the contrary, an employee of the state lottery or of a public 1.8 corporation or nonprofit corporation created by law may not receive bonus payments in 1.9 any year that exceed ten percent of the employee's base salary for that year. For purposes 1 10 of this section subdivision, bonus payments include any combination of merit pay, 1 11 achievement awards, or any other cash payments in addition to base salary, other than 1.12 severance pay or overtime or holiday pay. Groups covered by this section include, but 1.13 are not limited to, the Workers' Compensation Reinsurance Association, the Minnesota 1.14 Insurance Guaranty Association, the Fair plan, the Joint Underwriters Association, the 1.15 Minnesota Joint Underwriters Association, the Life and Health Guaranty Association, the 1 16 Minnesota Comprehensive Health Association, the Minnesota State High School League, 1.17 Enterprise Minnesota, Inc., Agricultural Utilization Research Institute, Minnesota Project 1 18 Outreach Corporation, and the State Agricultural Society. This section does not give any 1 19 entity authority to grant a bonus not otherwise authorized by law. 1.20 Subd. 2. No bonuses for state employees. Notwithstanding any law to the 1.21 contrary, an employee of the state, including the executive, legislative, and judicial 1.22

- branch, Minnesota State Colleges and Universities, and an employee of a county, city, 1.23
- school district, or other political subdivision may not receive bonus payments. For 1.24
