1.8	Section 1. [84.9401] AGGREGATE RESOURCES PERMIT COMPLAINTS.
1.9	(a) A person may file a written complaint with the commissioner of natural resources if
1.10	the person believes a local unit of government has unnecessarily delayed, denied, or
1.11	established conditions for a conditional land use permit or other permit necessary to mine
1.12	or temporarily process aggregate resources used for roads. The complaint must be filed in
1.13	a manner determined by the commissioner. The commissioner must review the complaint
1.14	to determine whether the local unit of government acted outside of its authority or established
1.15	unnecessary conditions for a permit. If the commissioner determines the local unit of
1.16	government acted outside of its authority or established unnecessary conditions, the
1.17	commissioner must provide an impeded activity determination to the commissioner of
1.18	transportation.
1.19	(b) At the request of a local unit of government, the commissioner of natural resources
1.20	must review the status of an impeded activity determination previously made under this
1.21	section. If the commissioner of natural resources confirms the local unit of government is
1.22	no longer acting outside of its authority or establishing unnecessary conditions, the
1.23	commissioner of natural resources must provide a cancellation notice terminating the impeded
