1.6	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.7	Section 1. Minnesota Statutes 2018, section 297A.94, is amended to read:
1.8	297A.94 DEPOSIT OF REVENUES.
1.9	(a) Except as provided in this section, the commissioner shall deposit the revenues,
1.10	including interest and penalties, derived from the taxes imposed by this chapter in the state
1.11	treasury and credit them to the general fund.
1.12	(b) The commissioner shall deposit taxes in the Minnesota agricultural and economic
1.13	account in the special revenue fund if:
1.14	(1) the taxes are derived from sales and use of property and services purchased for the
1.15	construction and operation of an agricultural resource project; and
1.16	(2) the purchase was made on or after the date on which a conditional commitment was
1.17	made for a loan guaranty for the project under section 41A.04, subdivision 3.
1.18	The commissioner of management and budget shall certify to the commissioner the date on
1.19	which the project received the conditional commitment. The amount deposited in the loan
1.20	guaranty account must be reduced by any refunds and by the costs incurred by the Department
1.21	of Revenue to administer and enforce the assessment and collection of the taxes.

(c) The commissioner shall deposit the revenues, including interest and penalties, derived
from the taxes imposed on sales and purchases included in section 297A.61, subdivision 3,
paragraph (g), clauses (1) and (4), in the state treasury, and credit them as follows:
(1) first to the general obligation special tax bond debt service account in each fiscal
year the amount required by section 16A.661, subdivision 3, paragraph (b); and
(2) after the requirements of clause (1) have been met, the balance to the general fund.
(d) Beginning with sales taxes remitted after July 1, 2017, the commissioner shall deposit

in the state treasury the revenues collected under section 297A.64, subdivision 1, including
interest and penalties and minus refunds, and credit them to the highway user tax distribution
fund.

(e) The commissioner shall deposit the revenues, including interest and penalties,
collected under section 297A.64, subdivision 5, in the state treasury and credit them to the
general fund. By July 15 of each year the commissioner shall transfer to the highway user
tax distribution fund an amount equal to the excess fees collected under section 297A.64,
subdivision 5, for the previous calendar year.

(f) Beginning with sales taxes remitted after July 1, 2017, in conjunction with the deposit
of revenues under paragraph (d), the commissioner shall deposit into the state treasury and
credit to the highway user tax distribution fund an amount equal to the estimated revenues
derived from the tax rate imposed under section 297A.62, subdivision 1, on the lease or
rental for not more than 28 days of rental motor vehicles subject to section 297A.64. The
commissioner shall estimate the amount of sales tax revenue deposited under this paragraph
based on the amount of revenue deposited under paragraph (d).

(g) Starting after July 1, 2017, the commissioner shall deposit an amount of the 2.23 remittances monthly into the state treasury and credit them to the highway user tax 2.24 distribution fund as a portion of the estimated amount of taxes collected from the sale and 2.25 purchase of motor vehicle repair parts in that month. For the remittances between July 1, 2.26 2017, and June 30, 2019, the monthly deposit amount is \$2,628,000. For remittances in 2.27 each subsequent fiscal year, the monthly deposit amount is \$12,137,000. For purposes of 2.28 this paragraph, "motor vehicle" has the meaning given in section 297B.01, subdivision 11, 2.29 and "motor vehicle repair and replacement parts" includes (i) all parts, tires, accessories, 2.30 and equipment incorporated into or affixed to the motor vehicle as part of the motor vehicle 2.31 maintenance and repair, and (ii) paint, oil, and other fluids that remain on or in the motor 2.32 vehicle as part of the motor vehicle maintenance or repair. "tire" means any tire of the type used on highway vehicles, if wholly or partially made of
rubber and if marked according to federal regulations for highway use.

3.3 (h) 72.43 percent of the revenues, including interest and penalties, transmitted to the
3.4 commissioner under section 297A.65, must be deposited by the commissioner in the state
3.5 treasury as follows:

(1) 50 percent of the receipts must be deposited in the heritage enhancement account in
the game and fish fund, and may be spent only on activities that improve, enhance, or protect
fish and wildlife resources, including conservation, restoration, and enhancement of land,
water, and other natural resources of the state;

3.10 (2) 22.5 percent of the receipts must be deposited in the natural resources fund, and may
3.11 be spent only for state parks and trails;

3.12 (3) 22.5 percent of the receipts must be deposited in the natural resources fund, and may
3.13 be spent only on metropolitan park and trail grants;

(i) The revenue dedicated under paragraph (h) may not be used as a substitute for 3.19 traditional sources of funding for the purposes specified, but the dedicated revenue shall 3.20 supplement traditional sources of funding for those purposes. Land acquired with money 3.21 deposited in the game and fish fund under paragraph (h) must be open to public hunting 3.22 and fishing during the open season, except that in aquatic management areas or on lands 3.23 where angling easements have been acquired, fishing may be prohibited during certain times 3.24 3.25 of the year and hunting may be prohibited. - (c) The term also does not include wire or wood sparklers of not more than 100 grams 5.7 of mixture per item, other sparkling items which are nonexplosive and nonaerial and contain 5.8 75 grams or less of chemical mixture per tube or a total of 500 grams or less for multiple 5.9 5.10 tubes, snakes and glow worms, smoke devices, or trick noisemakers which include paper streamers, party poppers, string poppers, snappers, and drop pops, each consisting of not 5.11 more than twenty-five hundredths grains of explosive mixture. The use of items listed in 5.12 this paragraph is not permitted on public property. This paragraph does not authorize the 5.13 purchase of items listed in it by persons younger than 18 years of age. - 5.19 <u>device;</u>
- 5.20 (2) "APA 87-1" means the American Pyrotechnic Association Standard 87-1 from the
 5.21 Standard for Construction and Approval for Transportation of Fireworks, Novelties, and
 5.22 Theatrical Pyrotechnics, 2001 Edition;
- (3) "display fireworks" means firework devices in a finished state, exclusive of mere
 ornamentation, primarily intended for commercial displays that are designed to produce
 visible effects, audible effects, or both, by combustion, deflagration, or detonation. The
 term includes, but is not limited to, salutes containing more than 130 milligrams of explosive
 composition, aerial shells containing more than 40 grams of chemical composition exclusive
 of light charge, and other exhibition display items that exceed the limits contained in APA
 87-1 for aerial and audible devices;
- (4) "fireworks" means any device, other than sparkling devices, novelties, aerial and
 audible devices, or theatrical pyrotechnic articles that are intended to produce visible effects,
 audible effects, or both, by combustion, deflagration, or detonation. The term includes

6.1	(5) "novelties" means devices containing small amounts of pyrotechnic composition
6.2	that are listed in APA 87-1, sections 3.2, 3.3, and 3.4. The term includes deregulated
6.3	sparklers, snakes and glow worms, smoke devices, and trick noisemakers, including paper
6.4	streamers, party poppers, string poppers, snappers, drop pops, each consisting of not more
6.5	than 25/100 grains of explosive mixture; toy pistols, toy guns, in which paper caps containing
6.6	25/100 grains or less of explosive compound are used; and toy pistol caps that contain less
6.7	than 20/100 grains of explosive mixture; and
6.8	(6) "sparkling devices" means ground-based or handheld devices that produce a shower

6.13	persons younger than 18 years of age. A person selling sparkling devices or aerial and
6.14	audible devices shall verify the age of a purchaser by photographic identification.
6.15	(d) (c) A local unit of government may impose an annual license fee for the retail sale
6.16	of items authorized under paragraph (c) sparkling devices and aerial and audible devices.
6.17	The annual license fee of each retail seller that is in the business of selling only the items
6.18	authorized under paragraph (c) sparkling devices or aerial and audible devices, or both, may
6.19	not exceed \$350 for a single retail location, and the annual license of each other retail seller
6.20	may not exceed \$100. A local unit of government may assess a fee, not to exceed \$100, to
6.21	a licensee for each additional retail location that the licensee operates. A license application
6.22	must be made before June 1 of each year and must require, at a minimum, the location of
6.23	each retail location the licensee intends to operate. The local authority having jurisdiction
6.24	shall, within 14 days after the receipt of an application for a license, either issue the license
6.25	or notify the applicant of the denial of the license. A licensee must display the license issued
6.26	pursuant to this paragraph at each point of sale operated by the licensee. A license issued
