1.4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.5	Section 1. PARTNERSHIPS FOR HEALTHY FUTURES.
1.6	(a) The commissioner of health shall award grants to support the health of children,
1.7	families, and communities through promotion of safe, stable, nurturing relationships and
1.8	environments, and social, cultural, and economic well-being.
1.9	(b) The goals of grants shall be to build the capacity of community institutions to:
1.10	(1) identify and expand opportunities to strengthen population health and well-being
1.11	outcomes, with a focus on creating conditions to support healthy children, youth, families,
1.12	and communities; and
1.13	(2) focus on community level policy, systems, and environmental changes that
1.14	support safe, stable, nurturing relationships and environments, and social, cultural, and
1.15	economic well-being.
1.16	(c) To be eligible to receive a grant under this section, an applicant may be a local or
1.17	tribal government, nonprofit entity, or community agency, and must:
1.18	(1) demonstrate the ability to convene, coordinate across agencies and systems, and
1.19	implement evidence-based and practice-based strategies at the local level; and
1.20	(2) submit a plan that includes a community leadership team, community partners,
1.21	and a community action plan that includes an assessment of areas of strengths and needs,
1.22	proposed action strategies, technical assistance needs, and a staffing plan.
1.23	(d) When making grants under this section, preference shall be given to applicants
1.24	that serve communities where the percentage of households with children under five years
