1.8	Subdivision 1. <b>Definitions.</b> (a) As used in this section, the following terms have

1.10	(b) "Personal social media account" means an account with an electronic medium
1.11	or service where users may create, share, and view user-generated content, including but

(e) "Specific content" means data or information on a personal social media account
that is identified with sufficient particularity to:

it may share similar characteristics.
(f) "Student" means any student, participant, or trainee, whether full time or part
time, in an organized course of study at an educational institution.
Subd. 2. Prohibited disclosure requirements. An educational institution shall not:
(1) require, request, or coerce a student or prospective student to disclose the user
name and password, password, or any other means of authentication, or provide access
through the user name or password, to a personal social media account;
(2) require, request, or coerce a student or prospective student to access a personal
social media account in the presence of a school employee or school volunteer, including
but not limited to a coach, teacher, or school administrator, in a manner that enables the
school employee or school volunteer to observe the contents of the account; or
(3) compel a student or prospective student to add anyone, including a coach,
teacher, school administrator, or other school employee or school volunteer, to their list of
contacts associated with a personal social media account or require, request, or otherwise

Subd. 3. Prohibited educational institution actions. An educational institution

(b) Any educational institution employee or agent who violates this section may be subject to disciplinary proceedings and punishment. For educational institution employees who are represented under the terms of a collective bargaining agreement, this section prevails except where it conflicts with the collective bargaining agreement, any memorandum of agreement or understanding signed pursuant to the collective bargaining agreement, or any recognized and established practice relative to the members of the bargaining unit.

Subd. 7. **Severability.** The provisions in this section are severable. If any part or provision of this section, or the application of this section to any person, entity, or circumstance, is held invalid, the remainder of this section, including the application of the part or provision to other persons, entities, or circumstances, shall not be affected by the holding and shall continue to have force and effect.

**EFFECTIVE DATE.** This section is effective the day following final enactment.
