3.22 Subd. 3. **Investigation authority; complaint process.** (a) The board may investigate 3.23 any alleged or potential violation of this chapter. The board may also investigate an alleged 3.24 or potential violation of section 211B.04, 211B.12, or 211B.15 by or related to a candidate, 3.25 treasurer, principal campaign committee, political committee, political fund, or party unit, 3.26 as those terms are defined in this chapter. The board may only investigate an alleged violation 3.27 if the board:

3.29 (2) discovers a potential violation as a result of an audit conducted by the board; or

4.1 (b) When the board investigates the allegations made in a written complaint and the
4.2 investigation reveals other potential violations that were not included in the complaint, the
4.3 board may investigate the potential violations not alleged in the complaint only after making
4.4 a determination under paragraph (d) that probable cause exists to believe a violation that
4.5 warrants a formal investigation has occurred.

(c) Upon receipt of a written complaint filed with the board, the board chair or another 4.6 board member designated by the chair shall promptly make a determination as to whether 4.7 the complaint alleges a prima facie violation. If a determination is made that the complaint 4.8 does not allege a prima facie violation, the complaint shall be dismissed without prejudice 4.9 and the complainant and the subject of the complaint must be promptly notified of the 4.10 reasons the complaint did not allege a prima facie violation. The notice to the subject of the 4.11 complaint must include a copy of the complaint. If the complainant files a revised complaint 4.12 regarding the same facts and the same subject, the prima facie determination must be 4.13 completed by a board member other than the member who made the initial determination 4.14 and who does not support the same political party as the member who made the initial 4.15 determination. The chair may order that the prima facie determination for any complaint 4.16 be made by the full board and must order that the prima facie determination for a complaint 4.17 being submitted for the third time be made by the full board. 4.18

(d) If a determination is made that the complaint alleges a prima facie violation, the
board shall, within 45 60 days of the prima facie determination, make findings and
conclusions as to whether probable cause exists to believe the alleged violation that warrants
a formal investigation has occurred. Any party filing a complaint and any party against
whom a complaint is filed must be given an opportunity to be heard by the board prior to
the board's determination as to whether probable cause exists to believe a violation that

(e) Upon a determination by the board that probable cause exists to believe a violation 4.26 that warrants a formal investigation has occurred, the board must undertake an investigation 4.27 under subdivision 2 and must issue an order at the conclusion of the investigation, except 4.28 that if the complaint alleges a violation of section 10A.25 or 10A.27, the board must either 4.29 enter a conciliation agreement or make public findings and conclusions as to whether a 4.30 violation has occurred and must issue an order within 60 days after the probable cause 4.31 determination has been made.
