BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. **LAKE SUPERIOR COLLEGE.**
- 1.6

Subdivision 1. **Appropriation.** \$1,055,000 is appropriated from the bond proceeds fund
- 1.7

to the Board of Trustees of the Minnesota State Colleges and Universities to design the
- 1.8

renovation and construction of integrated manufacturing workforce labs and related support
- 1.9

space and design the demolition of the maintenance shed at Lake Superior College.
- 1.10

Subd. 2. **Bond sale.** To provide the money appropriated in this section from the bond
- 1.11

proceeds fund, the commissioner of management and budget shall sell and issue bonds of
- 1.12

the state in an amount up to \$1,055,000 in the manner, upon the terms, and with the effect
- 1.13

prescribed by Minnesota Statutes, sections 16A.631 to 16A.675, and by the Minnesota

Constitution, article XI, sections 4 to 7.
