.8	permit, without a fee, to A person may use a muzzleloader with a scope to take deer
.9	during the muzzleloader season to a person who obtains the required licenses and who has
.10	a visual impairment. The scope may not have magnification capabilities.
.11	(b) The visual impairment must be to the extent that the applicant is unable
.12	to identify targets and the rifle sights at the same time without a scope. The visual

A physician, certified nurse practitioner, certified physician assistant, ophthalmologist, or optometrist who fraudulently certifies to the commissioner that a person is visually impaired as described in this subdivision is guilty of a misdemeanor.
