1.5	Section 1. NORTHEAST REGIONAL CORRECTIONS CENTER.
1.6	Subdivision 1. Appropriation. \$2,850,000 is appropriated from the bond
1.7	proceeds fund to the commissioner of administration for a grant to the Arrowhead
1.8	Regional Corrections Joint Powers Board to renovate, remodel, and complete other
1.9	capital improvements to buildings that support vocational, educational, and farm work
1.10	programming and experiences at the Northeast Regional Corrections Center. Nonstate
1.11	contributions to improvements at the center made before or after the enactment of this
1.12	section are considered to be a sufficient match and no further nonstate contribution is
1.13	required.
1.14	Subd. 2. Bond sale. To provide the money appropriated in this section from the
1.15	bond proceeds fund, the commissioner of management and budget shall sell and issue
