1.5	Section 1. EDINA; SOUTH METRO PUBLIC SAFETY TRAINING FACILITY.
1.6	Subdivision 1. Bond proceeds appropriation. \$3,700,000 is appropriated from the
1.7	bond proceeds fund to the commissioner of public safety for a grant to the city of Edina to
1.8	predesign, design, construct, expand, renovate, furnish, and equip improvements to the
1.9	South Metro Public Safety Training Facility. This appropriation does not require a nonstate
1.10	contribution.
1.11	(1) \$1,000,000 is to lengthen the four-lane shooting range to 75 feet.
