1.1 A bill for an act

relating to state lands; authorizing private sale of certain tax-forfeited land.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. PRIVATE SALE OF TAX-FORFEITED LAND; ST. LOUIS COUNTY.

- (a) Notwithstanding the public sale provisions of Minnesota Statutes, chapter 282, or other law to the contrary, St. Louis County may sell by private sale the tax-forfeited lands described in paragraph (c).
- (b) The conveyances must be in a form approved by the attorney general. The attorney general may make changes to the land descriptions to correct errors and ensure accuracy.
- (c) The lands to be sold are located in St. Louis County and are described as:
 - (1) that part of the following described parcel lying westerly of the centerline of 1st

 Avenue North, Kelly Lake, said parcel in the Northwest Quarter of the Southwest Quarter,
 assuming the west line of said Northwest Quarter of the Southwest Quarter to be North and
