| 1.8 | Sec. 2. MEMBERS; APPOINTMENT, TERM, MEETINGS, QUORUM. |
| 1.9 | The commission, consisting of three members, shall be appointed by the village |
| 1.10 | council for a term of three years. The original appointees shall serve one, two and three |
| 1.11 | years respectively as designated by the council. Each commissioner shall hold office until |
| 1.12 | his successor is appointed and qualified by subscribing to an oath that he will faithfully |
| 1.13 | and impartially perform the duties of this office. A member of the commission shall be |
| 1.14 | chairman of the commission during the last year of the term for which he is appointed. All |
