1.5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.6	Section 1. Minnesota Statutes 2022, section 609.324, subdivision 1, is amended to read:
1.7	Subdivision 1. Engaging in, hiring, or agreeing to hire minor to engage in
1.8	prostitution; penalties. (a) Whoever intentionally does any of the following may be
1.9	sentenced to imprisonment for not more than 20 years or to payment of a fine of not more
1.10	than \$40,000, or both:
1.11	(1) engages in prostitution with an individual under the age of 14 years;
1.12	(2) hires or offers or agrees to hire an individual under the age of 14 years to engage in
1.13	sexual penetration or sexual contact; or
1.14	(3) hires or offers or agrees to hire an individual who the actor reasonably believes to
1.15	be under the age of 14 years to engage in sexual penetration or sexual contact.
1.16	(b) Whoever intentionally does any of the following may be sentenced to imprisonment

2.8	(2) hires or offers or agrees to hire an individual under the age of 18 years but at least

2.13 EFFECTIVE DATE. This section is effective August 1, 2024, and applies to crimes
