Subd. 5. Crime of violence. EFFECTIVE DATE. This section is effective August 1, 2024, and applies to crimes committed on or after that date.

Sec. 9. OFFICE OF ANIMAL PROTECTION; APPROPRIATION.

\$350,000 in fiscal year 2025 is appropriated from the general fund to the commissioner of public safety to establish and operate the Office of Animal Protection established under this act.
