1.8	Subdivision 1. Appropriation. (a) \$51,000,000 is appropriated from the bond proceeds
1.9	account in the state transportation fund to the commissioner of transportation for one or
1.10	more grants to Anoka County, the city of Blaine, or both, for intersection improvements at
1.11	105th Avenue Northeast and marked Trunk Highway 65, and at Anoka County State-Aid
1.12	Highway 12, known as 109th Avenue Northeast, and marked Trunk Highway 65, and if
1.13	necessary for the construction of any associated: (1) frontage roads; (2) backage roads; (3)
1.14	connecting local roads; and (4) utility infrastructure improvements. This appropriation does
1.15	not require a nonstate contribution.
1.16	(b) \$12,000,000 of the appropriation in paragraph (a) is for acquisition of rights-of-way
1.17	associated with the local road portions of the project.
1.18	(c) \$39,000,000 of the appropriation in paragraph (a) is for construction of the
