1.1 A bill for an act
1.2 relating to capital investment; appropriating money for the reconstruction of Myrtle
1.3 Street in the city of Stillwater; authorizing the sale and issuance of state bonds.

1.4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.5 Section 1. STILLWATER; MYRTLE STREET RECONSTRUCTION.

1.6 Subdivision 1. Appropriation. \$1,927,000 is appropriated from the bond proceeds fund
1.7 to the commissioner of transportation for a grant to the city of Stillwater to design and
1.8 reconstruct Myrtle Street from Owens Street to Main Street. This appropriation includes
1.9 money for the replacement of sidewalk, curb, gutter, and associated public infrastructure.

1.10 Subd. 2. Bond sale. To provide the money appropriated in this section from the bond
1.11 proceeds fund, the commissioner of management and budget shall sell and issue bonds of
1.12 the state in an amount up to \$1,927,000 in the manner, upon the terms, and with the effect
1.13 prescribed by Minnesota Statutes, sections 16A.631 to 16A.675, and by the Minnesota
1.14 Constitution, article XI, sections 4 to 7.

1.15 EFFECTIVE DATE. This section is effective the day following final enactment.
