| 1.6 | Section 1. TASK FORCE ON PERSON-CENTERED TELEPRESENCE PLATFORM |
| 1.7 | EXPANSION. |
| 1.8 | Subdivision 1. Purpose. Minnesota's aging population and scarce workforce has caused |
| 1.9 | pressure on all industries, including health and human services, to improve productivity. |
| 1.10 | Innovation is the main source of productivity improvement. Thriving industries in the United |
| 1.11 | States are transforming digitally, focusing on improving customer experiences, innovating |
| 1.12 | industry business and platform models, and driving costs down by leveraging scale and |
| 1.13 | cloud opportunities. The Minnesota community innovation model has demonstrated the |
| 1.14 | value of adapting these strategies for person-centered innovation using Internet telepresence |
| 1.15 | to incentivize local and regional collaborative initiatives in health and human services and |
| 1.16 | related education and correctional services. The purpose of the task force is to share |
| 1.17 | knowledge at the local level and create the opportunity to adapt and expand this innovation |
| 1.18 | model throughout Minnesota. |
| 1.19 | Subd. 2. Membership. The task force on person-centered telepresence platform expansion |
| 1.20 | consists of the following 22 members: |
| 1.21 | (1) two members of the senate, one appointed by the majority leader and one appointed |
| 1.22 | by the minority leader; |

| 2.22 | (16) one member appointed by the governor representing adolescent treatment centers; |

| 2.25 | Subd. 3. Appointment deadline; first meeting; chair. Appointing authorities must |
| 2.26 | complete appointments by June 15, 2018. The director of telepresence integration shall |
| 2.27 | convene the first meeting of the task force by July 15, 2018. The task force shall select a |
| 2.28 | chair from among their members at their first meeting. |
| 2.29 | Subd. 4. Compensation. Members shall be compensated and may be reimbursed for |
| 2.30 | expenses as provided in Minnesota Statutes, section 15,059, subdivision 3. |

| 3.3 | delivery through the use of a common interoperable person-centered telepresence platform |
| 3.4 | that provides connectivity and technical support to potential users; |
| 3.5 | (2) review and coordinate state and local innovation initiatives and investments designed |
| 3.6 | to leverage telepresence connectivity and collaboration; |
| 3.7 | (3) identify standards and capabilities for a single interoperable telepresence platform; |
| 3.8 | (4) identify barriers to providing a telepresence technology, including limited availability |
| 3.9 | of bandwidth, limitations in providing certain services via telepresence, and broadband |
| 3.10 | infrastructure needs; |
| 3.11 | (5) identify and make recommendations for governance to assure person-centered |
| 3.12 | responsiveness; |
| 3.13 | (6) identify how the business model itself can be innovated to provide an incentive for |
| 3.14 | ongoing innovation in Minnesota's health and human service ecosystems; |
| 3.15 | (7) evaluate and make recommendations for a potential vendor that could provide a |
| 3.16 | single telepresence platform in terms of delivering the identified standards and capabilities; |
| 3.17 | (8) identify sustainable financial support for a single telepresence platform, including |
| 3.18 | infrastructure costs and start-up costs for potential users; and |
| 3.19 | (9) identify the benefits to the state, political subdivisions, and tribal governments, and |
| 3.20 | the constituents they serve in using a common person-centered telepresence platform for |
| 3.21 | delivering behavioral health services. |
| 3.22 | Subd. 6. Report. The task force shall report to the chairs and ranking minority members |
| 3.23 | of the committees in the senate and the house of representatives with primary jurisdiction |
| 3.24 | over health and state information technology by January 15, 2019, with recommendations |
| 3.25 | related to expanding the state's telepresence platform and any legislation required to |
| 3.26 | implement the recommendations. |
| 3.27 | Subd. 7. Administrative support. The commissioner of human services shall provide |
| 3.28 | meeting space and administrative services to the task force. |
| 3.29 | Subd. 8. Sunset. The task force sunsets July 31, 2019, or the day after the task force |
| 3.30 | submits the report required in this section, whichever is earlier. |
