1.2 relating to claims against the state; providing for settlement of certain claims;

1.3 appropriating money.

1.4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.5 Section 1. **EXONERATION AWARDS.**

1.6 The amounts in this section are appropriated in fiscal year 2019 from the general fund

1.7 to the commissioner of management and budget for full payment of awards of damages

1.8 under the Imprisonment and Exoneration Remedies Act, Minnesota Statutes, sections

1.9 611.362 to 611.368. This appropriation is available until June 30, 2019, for payment to:

1.10 (1) Sammy Gerald Jackson, \$20,446.08;

1.11 (2) Hollis John Larson, \$82,500; and

1.12 (3) Ronnie Earl Patterson, \$131,636.30.

1.13 Sec. 2. **DEPARTMENT OF REVENUE.**

1.14 \$12,305.67 in fiscal year 2019 is appropriated from the general fund to the commissioner

1.15 of revenue for full and final payment of the claim by Randy Dooley of Willmar, Minnesota,

1.16 for the amount of taxes paid to Minnesota for transactions occurring in South Dakota. This

1.17 appropriation is available until June 30, 2019.

1.18 Sec. 3. **DEPARTMENT OF CORRECTIONS; APPROPRIATION.**

1.19 The amounts in this section are appropriated from the general fund to the commissioner

1.20 of corrections in fiscal year 2019 for full and final payment under Minnesota Statutes,

2.1 sections 3.738 and 3.739, of claims against the state for losses suffered while incarcerated
2.2 in a state correctional facility or for injuries suffered by and medical services provided to
2.3 persons injured while performing community service or sentence-to-service work for
2.4 correctional purposes or while incarcerated in a state correctional facility. This appropriation
2.5 is available until June 30, 2019:

2.6 (1) for sentence-to-service and community work service claims under \$7,000 and other
2.7 claims already paid by the department, \$4,195.26; and

2.8 (2) for payment to Joseph Rosales for permanent injuries to his right index, middle, and
2.9 ring fingers sustained while performing assigned duties at Minnesota Correctional Facility
2.10 - Stillwater, \$10,209.
