1.5	Section 1. MINNESOTA GOES TO COLLEGE EXPANSION.
1.6	(a) The Office of Higher Education and the Minnesota Department of Education shall
1.7	explore an overall design to provide a comprehensive and uniform program promoting
1.8	Minnesota students' efforts to go to college and building on the existing Minnesota Goes
1.9	to College program to help the state in:
1.10	(1) obtaining the state higher education attainment goal under Minnesota Statutes, section
1.11	135A.012, to increase the number of Minnesota residents ages 25 to 44 years who hold
1.12	postsecondary degrees or certificates by at least 70 percent by 2025; and
1.13	(2) incentivizing Minnesota students to attend Minnesota institutions of higher learning.
1.14	(b) The Office of Higher Education and Department of Education shall explore the
