1.3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.4 Section 1. **LABOR AGREEMENTS AND COMPENSATION PLANS.**

1.5 **Subdivision 1. Minnesota State University Administrative and Service**
 1.6 **Faculty.** The labor agreement between the state of Minnesota and the Minnesota State
 1.7 University Administrative and Service Faculty, approved by the Legislative Coordinating
 1.8 Commission Subcommittee on Employee Relations on August 21, 2014, is ratified.

1.9 **Subd. 2. Minnesota State College Faculty.** The labor agreement between the
 1.10 state of Minnesota and the Minnesota State College Faculty, approved by the Legislative
 1.11 Coordinating Commission Subcommittee on Employee Relations on August 21, 2014,
 1.12 is ratified.

1.13 **Subd. 3. Minnesota Nurses Association.** The arbitration award and labor
 1.14 agreement between the state of Minnesota and the Minnesota Nurses Association,
 1.15 approved by the Legislative Coordinating Commission Subcommittee on Employee
 1.16 Relations on August 21, 2014, are ratified.

1.17 **Subd. 4. Inter Faculty Organization.** The labor agreement between the state of
 1.18 Minnesota and the Inter Faculty Organization, approved by the Legislative Coordinating
 1.19 Commission Subcommittee on Employee Relations on October 22, 2014, is ratified.

1.20 **Subd. 5. MnSCU Personnel Plan for Administrators.** The MnSCU Personnel
 1.21 Plan for Administrators, approved by the Legislative Coordinating Commission
 1.22 Subcommittee on Employee Relations on October 22, 2014, is ratified.

1.23 **Subd. 6. Minnesota Law Enforcement Association.** The arbitration award and
 1.24 labor agreement between the state of Minnesota and the Minnesota Law Enforcement

2.1 Association, approved by the Legislative Coordinating Commission Subcommittee on
2.2 Employee Relations on December 9, 2014, are ratified.

2.3 Sec. 2. **EFFECTIVE DATE.**

2.4 Section 1 is effective the day following final enactment.
