1.5	Section 1. [168.1294] "BREAST CANCER RESEARCH" PLATES.
1.6	Subdivision 1. Issuance of plates. The commissioner shall issue special "Breast
1.7	Cancer Research" plates or a single motorcycle plate to an applicant who:
1.8	(1) is a registered owner of a passenger automobile, noncommercial one-ton pickup
1.9	truck, motorcycle, or recreational motor vehicle;
1.10	(2) pays a fee of \$10 for each set of plates;
1.11	(3) pays the registration tax as required under section 168.013, along with any
