A bill for an act relating to human services; establishing a mobile food shelf grant program; appropriating money for mobile food shelves. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA: Section 1. MOBILE FOOD SHELF GRANTS. Subdivision 1. **Grant amount.** Hunger Solutions shall award grants under subdivision 3 of up to \$75,000 on a competitive basis. Subd. 2. **Application contents.** An applicant for a grant under this section must provide the following information to Hunger Solutions: (1) the location of the project; (2) a description of the mobile program, including size and scope; (3) evidence regarding the unserved or underserved nature of the community in which the project is to be located; (4) evidence of community support for the project; (5) the total cost of the project; (6) the amount of the grant request and how funds will be used; (7) sources of funding or in-kind contributions for the project that will supplement any grant award; (8) a commitment to mobile programs by the applicant and an ongoing commitment to maintain the mobile program; and (9) any additional information requested by Hunger Solutions. Subd. 3. Awarding grants. In evaluating applications and awarding grants, priority may be given to applicants who:

2.10	which is the association responsible for distributing food shelf funds under Minnesota
2.11	Statutes, section 256E.34, for mobile food shelf grants under section 1. This a onetime
