1.5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.6	Section 1. Minnesota Statutes 2016, section 116J.401, subdivision 2, is amended to read:
1.7	Subd. 2. Duties; authorizations; limitations. (a) The commissioner of employment
1.8	and economic development shall:
1.9	(1) provide regional development commissions, the Metropolitan Council, and units of
1.10	local government with information, technical assistance, training, and advice on using
1.11	federal and state programs;
1.12	(2) receive and administer the Small Cities Community Development Block Grant
1.13	Program authorized by Congress under the Housing and Community Development Act of
1.14	1974, as amended;
1.15	(3) receive and administer the section 107 technical assistance program grants authorized
1.16	by Congress under the Housing and Community Development Act of 1974, as amended;
1.17	(4) receive, administer, and supervise other state and federal grants and grant programs
1.18	for planning, community affairs, community development purposes, employment and
1.19	training services, and other state and federal programs assigned to the department by law
1.20	or by the governor in accordance with section 4.07;
1.21	(5) receive applications for state and federal grants and grant programs for planning,
1.22	community affairs, and community development purposes, and other state and federal

2.3	(6) act as the agent of, and cooperate with, the federal government in matters of mutual

2.7	(8) administer the Wagner-Peyser Act, the Workforce Investment Act, and other federal

2.14	(11) obtain reports from local service units and service providers for the purpose of

2.16	(12) as requested, certify employment and training services, and decertify services that

2.20	plans for Indian tribe employment and training services, review and comment on those

(30) study trends and developments in the industries of the state and analyze the reasons 4.1 underlying the trends; 4.2

(31) study costs and other factors affecting successful operation of businesses within 4.3 the state; 4.4

(33) serve as a clearing house for business and industrial problems of the state;

(34) advise small business enterprises regarding improved methods of accounting and 4.8 bookkeeping; 4.9

(35) cooperate with interstate commissions engaged in formulating and promoting the 4.10 adoption of interstate compacts and agreements helpful to business, industry, and commerce; 4.11

(36) cooperate with other state departments and with boards, commissions, and other 4.12

state agencies in the preparation and coordination of plans and policies for the development 4.13

of the state and for the use and conservation of its resources insofar as the use, conservation, 4.14

and development may be appropriately directed or influenced by a state agency; 4.15

(37) in connection with state, county, and municipal public works projects, assemble 4.16 and coordinate information relative to the status, scope, cost, and employment possibilities 4.17 and availability of materials, equipment, and labor, and recommend limitations on the public 4.18 works; 4.19

(38) gather current progress information with reference to public and private works 4.20 projects of the state and its political subdivisions with reference to conditions of employment; 4.21

(39) inquire into and report to the governor, when requested by the governor, with respect 4.22 to any program of public state improvements and its financing; and request and obtain 4.23 information from other state departments or agencies as may be needed for the report; 4.24

(40) study changes in population and current trends and prepare plans and suggest policies 4.25 for the development and conservation of the resources of the state; 4.26

(41) confer and cooperate with the executive, legislative, or planning authorities of the 4.27 United States, neighboring states and provinces, and the counties and municipalities of 4.28 neighboring states, for the purpose of bringing about a coordination between the development 4.29 of neighboring provinces, states, counties, and municipalities and the development of this 4.30 state; 4.31

(42) generally gather, compile, and make available statistical information relating to 5.1 business, trade, commerce, industry, transportation, communication, natural resources, and 5.2 other like subjects in this state, with authority to call upon other state departments for 5.3 statistical data and results obtained by them and to arrange and compile that statistical 5.4 information in a reasonable manner; 5.5

(43) publish documents and annually convene regional meetings to inform businesses, 5.6 local government units, assistance providers, and other interested persons of changes in 5.7 state and federal law related to economic development; 5.8

Measures include 5.16 source of funds for each program, number of jobs proposed or promised at the time of 5.17 application and the number of jobs created, estimated number of jobs retained, the average 5.18 salary and benefits for the jobs resulting from the program, and the number of projects 5.19 approved; 5.20

(47) provide a continuous program of education for business people; 5.21

(48) publish, disseminate, and distribute information and statistics; 5.22

(49) promote and encourage the expansion and development of markets for Minnesota 5.23 products; 5.24

(50) promote and encourage the location and development of new businesses in the state 5.25 as well as the maintenance and expansion of existing businesses and for that purpose 5.26 cooperate with state and local agencies and individuals, both within and outside the state; 5.27

(51) advertise and disseminate information as to natural resources, desirable locations, 5.28 and other advantages for the purpose of attracting businesses to locate in this state; 5.29

(52) aid the various communities in this state in attracting business to their communities; 5.30

(53) advise and cooperate with municipal, county, regional, and other planning agencies 5.31 and planning groups within the state for the purpose of promoting coordination between 5.32

6.4 (54) coordinate the activities of statewide and local planning agencies, correlate

(b) At the request of any governmental subdivision in paragraph (a), clause (53), the 6.15 commissioner may provide planning assistance, which includes but is not limited to surveys, 6.16 land use studies, urban renewal plans, technical services and other planning work to any 6.17 city or other municipality in the state or perform similar planning work in any county or 6.18 metropolitan or regional area in the state. The commissioner must not perform the planning 6.19 work with respect to a metropolitan or regional area which is under the jurisdiction for 6.20 planning purposes of a county, metropolitan, regional, or joint planning body, except at the 6.21 request or with the consent of the respective county, metropolitan, regional, or joint planning 6.22 body. 6.23

6.24 (c) The commissioner is authorized to:

6.25 (1) receive and expend money from municipal, county, regional, and other planning6.26 agencies;

6.27 (2) accept and disburse grants and other aids for planning purposes from the federal6.28 government and from other public or private sources;

6.29 (3) utilize money received under clause (2) for the employment of consultants and other
6.30 temporary personnel to assist in the supervision or performance of planning work supported
6.31 by money other than state-appropriated money;

- (4) enter into contracts with agencies of the federal government, units of local government
 or combinations thereof, and with private persons that are necessary in the performance of
 the planning assistance function of the commissioner; and
- 7.4 (5) assist any local government unit in filling out application forms for the federal7.5 grants-in-aid.
- 7.6 (d) In furtherance of its planning functions, any city or town, however organized, may
- 7.7 expend money and contract with agencies of the federal government, appropriate departments
- 7.8 of state government, other local units of government, and with private persons.
