BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. <u>CITY OF FOREST LAKE AND FOREST LAKE ECONOMIC</u> DEVELOPMENT AUTHORITY; TAX INCREMENT FINANCING DISTRICT.

Notwithstanding Minnesota Statutes, section 469.176, or any other law to the contrary, the Forest Lake Economic Development Authority and the city of Forest Lake may extend the duration of and collect tax increments from the Tax Increment Financing District No. 21 through December 31, 2025, subject to the conditions described in section 2.

Sec. 2. CONDITIONS FOR EXTENSION.
