1.5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.6	Section 1. [120B.25] ACADEMIC BALANCE POLICY.
1.7	Subdivision 1. Policy required. A school board must adopt a written academic balance
1.8	policy that applies to pupils, teachers, administrators, and other school personnel. The policy
1.9	must include reporting procedures and appropriate disciplinary actions for policy violations.
1.10	The disciplinary actions must conform with collective bargaining agreements and sections
1.11	121A.41 to 121A.56. A district must conspicuously post the policy throughout each school
1.12	building, provide a copy to each district employee, and include the policy in the student
1.13	handbook.
1.14	Subd. 2. Policy components. The academic balance policy must, at a minimum:
1.15	(1) prohibit school employees, in their official capacity, from requiring students or other
1.16	school employees to express specified social or political viewpoints for the purposes of
1.17	academic credit, extracurricular participation, or as a condition of employment;
1.18	(2) require the school to provide a learning environment, curriculum, and instruction
1.19	with access to a broad range of serious opinions pertaining to the subjects of study, including
1.20	contemporary policy controversies. Public education courses are not for the purpose of
1.21	political, ideological, religious, or antireligious indoctrination;
