APPROPRIATION; CITY OF WINDOM. 1.5 (a) \$13,000,000 in fiscal year 2023 is appropriated from the general fund to the 1.6 commissioner of revenue for a grant to the city of Windom to be allocated as provided under 1.7 paragraph (b). This appropriation is onetime and is available until June 30, 2025. 1.8 (b) Of the amount appropriated under paragraph (a): 1.9 (1) \$10,000,000 must be used by the city to facilitate completion of the Windom HyLife 1.10 Affordable Housing Development; 1.11 (2) \$2,000,000 must be used by the city for repayment of loans issued to the city from 1.12 the Public Facilities Authority for wastewater improvements related to the HyLife Foods 1.13 Windom processing plant; and 1.14 (3) \$1,000,000 must be used by the city for recruitment efforts including locating and 1.15 securing a purchaser of the HyLife Foods Windom processing plant. 1.16 (c) The appropriations under paragraph (b), clauses (1) and (2), are contingent upon 1.17 certification from the city that Hylife Foods has not entered into a contract to transfer 1.18 ownership of the Hylife Foods Windom processing plant. Certification from the city to the 1.19 commissioner of revenue must be made on or before July 1, 2023. 1.20
