[145.9275] AMYOTROPHIC LATERAL SCLEROSIS RESEARCH 1.7 **GRANTS.** 1.8 Subdivision 1. Grant program established. (a) The commissioner of health shall 1.9 establish a grant program to award grants by June 30 of each year to institutions in Minnesota 1.10 for research into amyotrophic lateral sclerosis (ALS). Grants shall be awarded to support 1.11 clinical and translational research related to ALS. Research topics may include but are not 1.12 limited to environmental factors, disease mechanisms, disease models, biomarkers, drug 1.13 development, clinical studies, precision medicine, medical devices, assistive technology, 1.14 and cognitive studies. 1.15 (b) Eligible applicants for the grants are research facilities, universities, and health 1.16 systems located in Minnesota. Applicants must submit proposals to the commissioner by 1.17 March 31 of each year. 1.18 (c) An ALS account is established in the special revenue fund.
