| 1.5        | Section 1. Minnesota Statutes 2022, section 129C.10, subdivision 3, is amended to read:   |
| 1.6        | Subd. 3. Powers and duties of board. (a) The board has the powers necessary for the   |
| 1.7        | care, management, and control of the Perpich Center for Arts Education and any other school   |
| 1.8        | authorized in this chapter, and all their real and personal property. The powers shall include,   |
| 1.9        | but are not limited to, those listed in this subdivision.   |
| 1.10       | (b) The board may employ and discharge necessary employees, and contract for other  |
| 1.11       | services to ensure the efficient operation of the Center for Arts Education and any other   |
| 1.12       | school authorized in this chapter.  |
| 1.13       | (c) The board may receive and award grants. The board may establish a charitable  |
| 1.14       | foundation and accept, in trust or otherwise, any gift, grant, bequest, or devise for educational   |
| 1.15       | purposes and hold, manage, invest, and dispose of them and the proceeds and income of   |
| 1.16       | them according to the terms and conditions of the gift, grant, bequest, or devise and its   |

| 2.22 | (k) The board may enter into contracts with other public and private agencies and              |

(m) The board may provide for transportation of pupils to and from the Center for Arts 3.1 Education for all or part of the school year, as the board considers advisable and subject to 3.2 its rules. Notwithstanding any other law to the contrary, the board may charge a reasonable 3.3 fee for transportation of pupils. Every driver providing transportation of pupils under this 3.4 paragraph must possess all qualifications required by the commissioner of education. The 3.5 board may contract for furnishing authorized transportation under rules established by the 3.6 commissioner of education and may purchase and furnish gasoline to a contract carrier for 3.7 use in the performance of a contract with the board for transportation of pupils to and from 3.8 the Center for Arts Education. When transportation is provided, scheduling of routes, 3.9 establishment of the location of bus stops, the manner and method of transportation, the 3.10 control and discipline of pupils, and any other related matter is within the sole discretion, 3.11 control, and management of the board. 3.12

3.13 (n) The board may provide room and board for its pupils. If the board provides room
3.14 and board, it shall charge a reasonable fee for the room and board. The fee is not subject to
3.15 chapter 14 and is not a prohibited fee according to sections 123B.34 to 123B.39.

3.16 (o) The board may establish and set fees for services and programs. If the board sets
3.17 fees not authorized or prohibited by the Minnesota public school fee law, it may do so
3.18 without complying with the requirements of section 123B.38.

3.19 (p) The board may apply for all competitive grants administered by agencies of the state3.20 and other government or nongovernment sources.

3.23 The director must report the following to the education committees of the legislature by3.24 January 15 of each year in accordance with section 3.195:

3.25 (1) outreach activities, including the number of districts, teachers, and administrators

3.26 that have participated in outreach the center's professional development and resource
3.27 programs;

- 3.28 (2) the impact of the center's outreach activities a description of the Perpich Arts High
- 3.29 School and summary of course offerings, graduating students' postsecondary plans, and
- 3.30 other summary data, including but not limited to average class size and number of Minnesota
- 3.31 <u>high schools represented; and</u>

- 4.1 (3) enrollment trends, including the number of students from each congressional district
- 4.2 admitted to the Perpich Arts High School and efforts to increase enrollment by 20 percent
- 4.3 by 2019; and an overview of the arts library's circulation, visitors, and staffing.
- 4.4 (4) students' academic achievement, including performance on standard assessments,
- 4.5 graduation rates, and the number of students enrolled in postsecondary education.
