MINNESOTA INDIAN FAMILY PRESERVATION ACT PROVISIONS

1.18

Section 1. Minnesota Statutes 2023 Supplement, section 260.755, subdivision 1a, is

amended to read:

1.20

Subd. 1a. **Active efforts.** (a) "Active efforts" means a rigorous and concerted level of

1.21

effort to preserve the Indian child's family that is ongoing throughout the involvement of

1.22

the child-placing agency to continuously involve the Indian child's Tribe and that uses the

1.23

or the petitioner with the Indian child. Active efforts require the engagement of the Indian

1.24

child, the Indian child's parents, the Indian custodian, the extended family, and the Tribe in

1.25

using the prevailing social and cultural values, conditions, and way of life of the Indian

1.26

child's Tribe to: (1) preserve the Indian child's family and; (2) prevent placement of an

1.27

Indian child and; (3) if placement occurs, to return the Indian child to the Indian child's

family at the earliest possible time; and (4) where a permanent change in parental rights or custody are necessary, ensure the Indian child retains meaningful connections to the Indian child's family, extended family, and Tribe.

(b) Active efforts ~~under section~~ for all Indian child placements includes this section and sections 260.012 and 260.762 and require a higher standard than reasonable efforts as defined in section 260.012 to preserve the family, prevent breakup of the family, and reunify the family. Active efforts ~~include reasonable efforts as required by Title IV-E of the Social Security Act, United States Code, title 42, sections 670 to 679e~~ are required for all Indian child placement proceedings and for all voluntary Indian child placements that involve a child-placing agency regardless of whether the reasonable efforts would have been relieved under section 260.012.

Sec. 2. Minnesota Statutes 2022, section 260.755, subdivision 2a, is amended to read:

Subd. 2a. **Best interests of an Indian child.** "Best interests of an Indian child" means compliance with the federal Indian Child Welfare Act and the Minnesota Indian Family Preservation Act to preserve and maintain an Indian child's family. The best interests of an Indian child support the Indian child's sense of belonging to family, extended family, and Tribe. The best interests of an Indian child are interwoven with the best interests of the Indian child's Tribe.

Sec. 3. Minnesota Statutes 2023 Supplement, section 260.755, subdivision 3, is amended to read:

Subd. 3. **Child placement proceeding.** (a) "Child placement proceeding" includes a judicial proceeding which could result in:

(1) "adoptive placement," meaning the permanent placement of an Indian child for adoption, including an action resulting in a final decree of adoption;

(2) "involuntary foster care placement," meaning an action removing an Indian child from the child's parents or Indian custodian for temporary placement in a foster home, institution, or the home of a guardian. The parent or Indian custodian cannot have the Indian child returned upon demand, but parental rights have not been terminated;

(3) "preadoptive placement," meaning the temporary placement of an Indian child in a foster home or institution after the termination of parental rights, before or instead of adoptive placement; or

(4) "termination of parental rights," meaning an action resulting in the termination of the parent-child relationship under section 260C.301.

(b) The term child placement proceeding is a domestic relations proceeding that includes all placements where Indian children are placed out-of-home or away from the care, custody, and control of their parent or parents or Indian custodian that do not implicate custody between the parents. Child placement proceeding also includes any placement based upon juvenile status offenses, but does not include a placement based upon an act which if committed by an adult would be deemed a crime, or upon an award of custody in a divorce proceeding to one of the parents.

Sec. 4. Minnesota Statutes 2023 Supplement, section 260.755, subdivision 3a, is amended to read:

Subd. 3a. **Child-placing agency.** "Child-placing agency" means a public, private, or nonprofit legal entity: (1) providing assistance to ~~a~~ an Indian child and the Indian child's parent or parents or Indian custodian; or (2) placing ~~a~~ an Indian child in foster care or for adoption on a voluntary or involuntary basis.

Sec. 5. Minnesota Statutes 2022, section 260.755, subdivision 5, is amended to read:

Subd. 5. **Demand.** "Demand" means a written and notarized statement signed by a parent or Indian custodian of ~~a~~ an Indian child which requests the return of the Indian child who has been voluntarily placed in foster care.

Sec. 6. Minnesota Statutes 2023 Supplement, section 260.755, subdivision 5b, is amended to read:

Subd. 5b. **Extended family member.** "Extended family member" is as defined by the law or custom of the Indian child's Tribe or, in the absence of any law or custom of the Tribe, is a person who has reached the age of 18 and who is the Indian child's grandparent, aunt or uncle, brother or sister, brother-in-law or sister-in-law, niece or nephew, first or second cousin, or stepparent. The legal parent, guardian, or custodian of the Indian child's sibling is not an extended family member or relative of an Indian child unless they are independently related to the Indian child or recognized by the Indian child's Tribe as an extended family member.

Sec. 7. Minnesota Statutes 2022, section 260.755, subdivision 14, is amended to read:

Subd. 14. **Parent.** "Parent" means the biological parent of an Indian child; or any ~~Indian~~ person who has lawfully adopted an Indian child, including a person who has adopted ~~a~~ an Indian child by Tribal law or custom. Parent includes a father as defined by Tribal law or custom. Parent does not include an unmarried father whose paternity has not been acknowledged or established. Paternity has been acknowledged when an unmarried father takes any action to hold himself out as the biological father of an Indian child.

Sec. 8. Minnesota Statutes 2022, section 260.755, is amended by adding a subdivision to read:

Subd. 15a. **Petitioner.** "Petitioner" means one or more individuals other than a parent or Indian custodian who has filed a petition or motion seeking a grant of temporary or permanent guardianship, custody, or adoption of an Indian child.

Sec. 9. Minnesota Statutes 2022, section 260.755, subdivision 17a, is amended to read:

Subd. 17a. **Qualified expert witness.** "Qualified expert witness" means an individual who ~~(1) has specific knowledge of the Indian child's tribe's culture and customs, or~~ meets the criteria in section 260.771, subdivision 6, paragraph (d), and ~~(2) provides testimony as required by the Indian Child Welfare Act of 1978, United States Code, title 25, section 1912, and the Minnesota Indian Family Preservation Act, regarding out-of-home placement or termination of parental rights~~ child placement or permanency proceedings relating to an Indian child.

Sec. 10. Minnesota Statutes 2023 Supplement, section 260.755, subdivision 20, is amended to read:

Subd. 20. **Tribal court.** "Tribal court" means a court with jurisdiction over child custody proceedings and which is either a court of Indian offenses, ~~or~~ a court established and operated under the code or custom of an Indian Tribe, or any other administrative body of a Tribe which is vested with authority over child custody proceedings.

Sec. 11. Minnesota Statutes 2022, section 260.755, is amended by adding a subdivision to read:

Subd. 20a. **Tribal representative.** "Tribal representative" means a representative designated by and acting on behalf of a Tribe in connection with an Indian child placement proceeding as defined in subdivision 3. It is not required that the designated representative

5.1 be an attorney to represent the Tribe in these matters. An individual appearing as a Tribal
5.2 representative on behalf of a Tribe and participating in a court proceeding under this chapter
5.3 is not engaged in the unauthorized practice of law.

5.4 Sec. 12. Minnesota Statutes 2023 Supplement, section 260.755, subdivision 22, is amended
5.5 to read:

5.6 Subd. 22. **Voluntary foster care placement.** "Voluntary foster care placement" means
5.7 a decision in which there has been participation by a child-placing agency resulting in the
5.8 temporary placement of an Indian child away from the home of the Indian child's parents
5.9 or Indian custodian in a foster home, institution, or the home of a guardian, and the parent
5.10 or Indian custodian may have the Indian child returned upon demand.

5.11 Sec. 13. Minnesota Statutes 2023 Supplement, section 260.758, subdivision 2, is amended
5.12 to read:

5.13 Subd. 2. **Temporary emergency jurisdiction of state courts.** (a) The child-placing
5.14 agency, petitioner, or court shall ensure that the emergency removal or placement terminates
5.15 immediately when removal or placement is no longer necessary to prevent imminent physical
5.16 damage or harm to the Indian child. The child-placing agency, petitioner, or court shall
5.17 expeditiously initiate a child placement proceeding subject to the provisions of sections
5.18 260.751 to 260.835, transfer the Indian child to the jurisdiction of the appropriate Indian
5.19 Tribe, or return the Indian child to the Indian child's parent or Indian custodian as may be
5.20 appropriate.

5.21 (b) If the Indian child is a resident of or is domiciled on a reservation but temporarily
5.22 located off the reservation, a court of this state has only temporary emergency jurisdiction
5.23 until the Indian child is transferred to the jurisdiction of the appropriate Indian Tribe unless
5.24 the Indian child's Tribe has expressly declined to exercise its jurisdiction, or the Indian child
5.25 is returned to the Indian child's parent or Indian custodian.

5.26 Sec. 14. Minnesota Statutes 2023 Supplement, section 260.758, subdivision 4, is amended
5.27 to read:

5.28 Subd. 4. **Emergency proceeding requirements.** (a) The court shall hold a hearing no
5.29 later than 72 hours, excluding weekends and holidays, after the emergency removal of the
5.30 Indian child. The court shall determine whether the emergency removal continues to be
5.31 necessary to prevent imminent physical damage or harm to the Indian child.

(b) The court shall hold additional hearings whenever new information indicates that the emergency situation has ended and must determine at any court hearing during the emergency proceeding ~~to determine~~ whether the emergency removal or placement is no longer necessary to prevent imminent physical damage or harm to the Indian child.

Sec. 15. Minnesota Statutes 2023 Supplement, section 260.758, subdivision 5, is amended to read:

Subd. 5. **Termination of emergency removal or placement.** (a) An emergency removal or placement of an Indian child must immediately terminate once the child-placing agency or court possesses sufficient evidence to determine that the emergency removal or placement is no longer necessary to prevent imminent physical damage or harm to the Indian child and the Indian child shall be immediately returned to the custody of the Indian child's parent or Indian custodian.

(b) An emergency removal or placement ends when the Indian child is transferred to the jurisdiction of the Indian child's Tribe, or when the court orders, after service upon the Indian child's parents, Indian custodian, and Indian child's Tribe, ~~that~~ placement of the Indian child ~~shall be placed in foster care~~ upon a determination supported by clear and convincing evidence, including testimony by a qualified expert witness, that custody of the Indian child by the Indian child's parent or Indian custodian is likely to result in serious emotional or physical damage to the Indian child.

(c) In no instance shall emergency removal or emergency placement of an Indian child extend beyond 30 days unless the court finds by a showing of clear and convincing evidence that: (1) continued emergency removal or placement is necessary to prevent imminent physical damage or harm to the Indian child; (2) the court has been unable to transfer the proceeding to the jurisdiction of the Indian child's Tribal court; and (3) it has not been possible to initiate a child placement proceeding with all of the protections under sections 260.751 to 260.835, including obtaining the testimony of a qualified expert witness.

Sec. 16. Minnesota Statutes 2023 Supplement, section 260.761, is amended to read:

260.761 INQUIRY OF TRIBAL LINEAGE; NOTICE TO TRIBES, PARENTS, AND INDIAN CUSTODIANS; ACCESS TO FILES.

Subdivision 1. **Inquiry of Tribal lineage.** (a) The child-placing agency or ~~individual~~ petitioner shall inquire of the child, the child's parents and custodians, and other appropriate persons whether there is any reason to believe that a child brought to the agency's attention may have lineage to an Indian Tribe. This inquiry shall occur at the time the child comes

7.1 to the attention of the child-placing agency or ~~individual~~ petitioner and shall continue
7.2 throughout the involvement of the child-placing agency or ~~individual~~ petitioner.

7.3 (b) In any child placement proceeding, the court shall inquire of the child, the child's
7.4 parents, custodian, and any person participating in the proceedings whether the child has
7.5 any American Indian heritage or lineage to an Indian Tribe. The inquiry shall be made at
7.6 the commencement of the proceeding and all responses must be on the record. The court
7.7 must instruct the parties to inform the court if they subsequently receive information that
7.8 provides reason to believe the child is an Indian child.

7.9 (c) If there is reason to believe the child is an Indian child, but the court does not have
7.10 sufficient evidence to determine whether the child is an Indian child, the court shall:

7.11 (1) confirm with a report, declaration, or testimony in the record that the child-placing
7.12 agency or petitioner used due diligence to identify and work with all of the Tribes for which
7.13 there is reason to believe the child may be a member of or eligible for membership to verify
7.14 whether the child is an Indian child; and

7.15 (2) proceed with the case as if the child is an Indian child until it is determined on the
7.16 record that the child does not meet the definition of Indian child.

7.17 Subd. 2. **Notice to Tribes of services or court proceedings involving an Indian**
7.18 **child.** (a) When a child-placing agency or petitioner has information that a family assessment,
7.19 investigation, or noncaregiver sex trafficking assessment being conducted may involve an
7.20 Indian child, the child-placing agency or petitioner shall notify the Indian child's Tribe of
7.21 the family assessment, investigation, or noncaregiver sex trafficking assessment according
7.22 to section 260E.18. The child-placing agency or petitioner shall provide initial notice by
7.23 telephone and by email or facsimile and shall include the child's full name and date of birth;
7.24 the full names and dates of birth of the child's biological parents; and if known the full
7.25 names and dates of birth of the child's grandparents and of the child's Indian custodian. If
7.26 information regarding the child's grandparents or Indian custodian is not immediately
7.27 available, the child-placing agency or petitioner shall continue to request this information
7.28 and shall notify the Tribe when it is received. Notice shall be provided to all Tribes to which
7.29 the child may have any Tribal lineage. The child-placing agency or petitioner shall request
7.30 that the Tribe or a designated Tribal representative participate in evaluating the family
7.31 circumstances, identifying family and Tribal community resources, and developing case
7.32 plans. The child-placing agency or petitioner shall continue to include the Tribe in service
7.33 planning and updates as to the progress of the case.

(b) When a child-placing agency or petitioner has information that a child receiving services may be an Indian child, the child-placing agency or petitioner shall notify the Tribe by telephone and by email or facsimile of the child's full name and date of birth, the full names and dates of birth of the child's biological parents, and, if known, the full names and dates of birth of the child's grandparents and of the child's Indian custodian. This notification must be provided for the Tribe to determine if the child is a member or eligible for Tribal membership, and the child-placing agency or petitioner must provide this notification to the Tribe within seven days of receiving information that the child may be an Indian child. If information regarding the child's grandparents or Indian custodian is not available within the seven-day period, the child-placing agency or petitioner shall continue to request this information and shall notify the Tribe when it is received. Notice shall be provided to all Tribes to which the child may have any Tribal lineage.

(c) In all child placement proceedings, when a court has reason to believe that a child placed in emergency protective care is an Indian child, the court administrator or a designee shall, as soon as possible and before a hearing takes place, notify the Tribal social services agency by telephone and by email or facsimile of the date, time, and location of the emergency protective care or other initial hearing. The court shall ~~make efforts to allow appearances by telephone or video conference for Tribal representatives, parents, and Indian custodians~~ allow appearances by telephone, video conference, or other electronic medium for Tribal representatives, the Indian child's parents, or the Indian custodian.

(d) In all child placement proceedings, when a court has reason to believe the child is an Indian child, the child-placing agency or individual petitioner shall effect service of any petition governed by sections 260.751 to 260.835 provide notice of the proceedings and a copy of any petition to the Indian child's parents, Indian custodian, and the Indian child's Tribe and shall effect service of any notice and petition governed by sections 260.751 to 260.835 upon the parent, Indian custodian, and the Indian child's Tribe by certified mail or registered mail, return receipt requested upon the Indian child's parents, Indian custodian, and Indian child's Tribe at least 10 days before the admit-deny hearing is held. If the identity or location of the Indian child's parents or Indian custodian ~~and or~~ or Tribe cannot be determined, the child-placing agency or petitioner shall provide the notice required in this paragraph to the United States Secretary of the Interior, Bureau of Indian Affairs by certified or registered mail, return receipt requested. Where service is only accomplished through the United States Secretary of the Interior, Bureau of Indian Affairs, the initial hearing shall not be held until 20 days after notice upon the Tribe or the Secretary of the Interior.

9.1 (e) Notice under this subdivision must be in clear and understandable language and
9.2 include the following:

9.3 (1) the child's name, date of birth, and birth place;

9.4 (2) all names known for the parents and Indian custodian, including maiden, married,
9.5 former names, and aliases, correctly spelled;

9.6 (3) the dates of birth, birth place, and Tribal enrollment numbers of the Indian child, the
9.7 Indian child's parents, and the Indian custodian, if known;

9.8 (4) the full names, dates of birth, birth places, and Tribal enrollment or affiliation
9.9 information of direct lineal ancestors of the child, other extended family members, and
9.10 custodians of the child, if known;

9.11 (5) the name of any and all Indian Tribes in which the child is or may be a member or
9.12 eligible for membership in; and

9.13 (6) statements setting out:

9.14 (i) the name of the petitioner and name and address of the petitioner's attorney;

9.15 (ii) the right of any parent or Indian custodian of the Indian child, to intervene in the
9.16 child custody proceedings, if not already a party;

9.17 (iii) the right of the Indian child's Tribe to intervene in the proceedings at any time;

9.18 (iv) the right of the Indian child, the Indian child's parent, and the Indian custodian to
9.19 court-appointed counsel if they meet the requirements in section 611.17;

9.20 (v) the right to be granted, upon request, up to 20 additional days to prepare for the
9.21 child-placement proceedings;

9.22 (vi) the right of the Indian child's parent, the Indian custodian, and the Indian child's
9.23 Tribe to petition the court for transfer of the proceedings to Tribal court;

9.24 (vii) the mailing addresses and telephone numbers of the court and information related
9.25 to all parental and custodial rights of the parent or Indian custodian; and

9.26 (viii) that all parties must maintain confidentiality of all information contained in the
9.27 notice and must not provide the information to anyone other than their attorney.

9.28 ~~(e)~~ (f) A Tribe, the Indian child's parents, or the Indian custodian may request up to 20
9.29 additional days to prepare for the ~~admit-deny~~ initial hearing. The court shall allow
9.30 appearances by telephone, video conference, or other electronic medium for Tribal
9.31 representatives, the Indian child's parents, or the Indian custodian.

10.1 ~~(f)~~ (g) A child-placing agency or ~~individual~~ petitioner must provide the notices required
10.2 under this subdivision at the earliest possible time to facilitate involvement of the Indian
10.3 child's Tribe. Nothing in this subdivision is intended to hinder the ability of the child-placing
10.4 agency, ~~individual~~ petitioner, and the court to respond to an emergency situation. Lack of
10.5 participation by a Tribe shall not prevent the Tribe from intervening in services and
10.6 proceedings at a later date. A Tribe may participate in a case at any time. At any stage of
10.7 the child-placing ~~agency's~~ agency or petitioner's involvement with an Indian child, the
10.8 child-placing agency or petitioner shall provide full cooperation to the Tribal social services
10.9 agency, including disclosure of all data concerning the Indian child. Nothing in this
10.10 subdivision relieves the child-placing agency or petitioner of satisfying the notice
10.11 requirements in state or federal law.

10.12 (h) The court shall allow appearances by telephone, video conference, or other electronic
10.13 means for Tribal representatives at all hearings and trials. The court shall allow appearances
10.14 by telephone, video conference, or other electronic means for the Indian child's parents or
10.15 Indian custodian for all hearings and shall allow such appearance for trials upon a showing
10.16 that appearance in person would be unduly burdensome.

10.17 Subd. 3. **Notice of potential preadoptive or adoptive placement.** In any adoptive or
10.18 preadoptive placement proceeding, including voluntary proceedings, where any party or
10.19 participant has reason to believe that a child who is the subject of an adoptive or preadoptive
10.20 placement proceeding is or may be an "Indian child," as defined in section 260.755,
10.21 subdivision 8, and United States Code, title 25, section 1903(4), the child-placing agency
10.22 or ~~individual~~ petitioner shall notify the Indian child's Tribe by registered mail or certified
10.23 mail with return receipt requested of the pending proceeding and of the right of intervention
10.24 under subdivision 6. If the identity or location of the Indian child's Tribe cannot be
10.25 determined, the notice must be given to the United States Secretary of Interior in like manner.
10.26 No preadoptive or adoptive placement proceeding may be held until at least 20 days after
10.27 receipt of the notice by the Tribe or the secretary. Upon request, the Tribe must be granted
10.28 up to 20 additional days to prepare for the proceeding. The child-placing agency or ~~individual~~
10.29 petitioner shall include in the notice the identity of the birth parents and Indian child absent
10.30 written objection by the birth parents. The child-placing agency or petitioner shall inform
10.31 the birth parents of the Indian child of any services available to the Indian child through the
10.32 child's Tribal social services agency, including child placement services, and shall
10.33 additionally provide the birth parents of the Indian child with all information sent from the
10.34 Tribal social services agency in response to the notice.

11.1 Subd. 4. **Unknown father.** If the child-placing agency, ~~individual~~ petitioner, the court,
11.2 or any party has reason to believe that a child who is the subject of a child placement
11.3 proceeding is or may be an Indian child but the father of the child is unknown and has not
11.4 registered with the fathers' adoption registry pursuant to section 259.52, the child-placing
11.5 agency or ~~individual~~ petitioner shall provide to the Tribe believed to be the Indian child's
11.6 Tribe information sufficient to enable the Tribe to determine the child's eligibility for
11.7 membership in the Tribe, including, but not limited to, the legal and maiden name of the
11.8 birth mother, her date of birth, the names and dates of birth of her parents and grandparents,
11.9 and, if available, information pertaining to the possible identity, Tribal affiliation, or location
11.10 of the birth father.

11.11 Subd. 5. **Proof of service of notice upon Tribe or secretary.** In cases where a
11.12 child-placing agency or party to an adoptive placement knows or has reason to believe that
11.13 a child is or may be an Indian child, proof of service upon the Indian child's Tribe or the
11.14 secretary of interior must be filed with the adoption petition.

11.15 Subd. 6. **Indian Tribe's right of intervention.** In any child placement proceeding under
11.16 sections 260.751 to 260.835, the Indian child's Tribe shall have a right to intervene at any
11.17 point in the proceeding.

11.18 Subd. 6a. **Indian Tribe's access to files.** At any stage of the child-placing agency's
11.19 agency or petitioner's involvement with an Indian child, the child-placing agency or petitioner
11.20 shall, upon request, give the Tribal social services agency full cooperation including access
11.21 to all files concerning the Indian child. If the files contain confidential or private data, the
11.22 child-placing agency or petitioner may require execution of an agreement with the Tribal
11.23 social services agency to maintain the data according to statutory provisions applicable to
11.24 the data.

11.25 Sec. 17. Minnesota Statutes 2023 Supplement, section 260.762, is amended to read:

Active efforts to preserve the Indian child's family include efforts to prevent placement of the Indian child to correct the conditions that led to the placement by ensuring remedial services and rehabilitative programs designed to prevent the breakup of the family were provided in a manner consistent with the prevailing social and cultural conditions of the Indian child's Tribe and in partnership with the Indian child, the Indian child's parents, the Indian custodian, extended family members, and Tribe, and that these efforts have proved unsuccessful.
