Whenever claiming that an easement acquired by 1.8 condemnation, or portion of an easement described in subdivision 2, is not being used for 1.9 the purposes for which it was acquired, the underlying fee owner may apply to the district 1.10 court of the county in which the land is situated for an order discharging the easement 1.11 or portion of the easement, upon such terms as are just and equitable. Due notice of 1.12 said application shall be given to all interested parties.
