1.7	Subdivision 1. <b>Appropriation.</b> \$2,500,000 is appropriated from the bond proceeds fund
1.8	to the Board of Trustees of the Minnesota State Colleges and Universities for the purposes
1.9	specified in Minnesota Statutes, section 135A.046. This appropriation is to repair roofs,
1.10	replace windows, restore masonry, and replace fire suppression pumps.
1.11	Subd. 2. Bond sale. To provide the money appropriated in this section from the bond
