1.4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.5	Section 1. FLOOD HAZARD MITIGATION GRANT; APPROPRIATION.
1.6	Subdivision 1. Appropriation. (a) \$1,250,000 is appropriated from the bond proceeds
1.7	fund to the commissioner of natural resources for the state share of a flood hazard mitigation
1.8	grant to the communities of Perley and Hendrum for publicly owned capital improvements
1.9	to prevent or alleviate flood damages under Minnesota Statutes, section 103F.161.
1.10 1.11	(b) Project priorities shall be determined by the commissioner as appropriate, based on need and consideration of available leveraging of federal, local, and state funds.
1.12	(c) For any project listed in this subdivision that the commissioner determines is not
1.13	ready to proceed or does not expend all the money allocated to it, the commissioner may
1.14	allocate that project's money to a project on the commissioner's priority list.
1.15	(d) To the extent that the cost of a project exceeds two percent of the median household
1.16	income in the municipality multiplied by the number of households in the municipality, this
1.17	appropriation is also for the local share of the project.
1.18	(e) Local project match may include all costs associated with planning, engineering,
1.19	acquisition, and construction. The project grants are based on a reimbursable payment
1.20	process and reconciliation of the project's shared costs will be finalized upon project
1.21	completion certification.
