(a) The license holder must submit data concerning 3.7 medication used for the treatment of opioid addiction to a central registry. The data must 3.8 include the name of each prescriber, the name and strength of the medication prescribed, 3.9 the quantity of the medication prescribed, and the quantity of the medication dispensed. 3.10 The data must be submitted in a method determined by the commissioner and must be 3.11 submitted for each client at the time of admission and discharge. The program must 3.12 document the date the information was submitted. This requirement is effective upon 3.13 implementation of changes to the Drug and Alcohol Abuse Normative Evaluation System 3.14 (DAANES) or development of an electronic system by which to submit the data. 3.15 (b) The license holder must ensure that data is submitted to the Prescription 3.16 Monitoring Program as required in section 152.126, subdivision 4. 3.17
