1.9	Subd. 2a. Petition following acquittal; referral originating from criminal court.
1.10	(a) A criminal court shall order simultaneous competency, mental illness or deficiency,
1.11	and civil commitment examinations in accordance with Minnesota Rules of Criminal
1.12	Procedure, rule 20.04, when the prosecutor or defense counsel doubts the defendant's
1.13	competency and a motion is made challenging competency or the court on its initiative
