1.1 A bill for an act  
1.2 relating to health; requiring commissioner of health to develop a list of authorized  
1.3 entities; allowing certain individuals to obtain and administer epinephrine without  
1.4 a prescription; proposing coding for new law in Minnesota Statutes, chapter 144.

1.5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.6 Section 1. **[144.999] LIFE-SAVING ALLERGY MEDICATION.**

1.7 Subdivision 1. **Definitions.** (a) For purposes of this section, the following terms  
1.8 have the meanings given.

1.9 (b) "Administer" means the direct application of an epinephrine auto-injector to  
1.10 the body of an individual.

1.11 (c) "Authorized entity" means recreation camps, colleges and universities, preschools  
1.12 and daycares, and any other entity or organization approved by the commissioner to obtain  
1.13 and administer epinephrine auto-injectors without a prescription, other than a school as  
1.14 described in section 121A.2207.

1.15 (d) "Commissioner" means the commissioner of health.

1.16 (e) "Epinephrine auto-injector" means a single-use device used for the automatic  
1.17 injection of a premeasured dose of epinephrine into the human body.

1.18 (f) "Provide" means to supply one or more epinephrine auto-injectors to an individual.

1.19 Subd. 2. **Commissioner duties.** The commissioner may identify additional entities  
1.20 or organizations where individuals may come in contact with allergens capable of causing  
1.21 anaphylaxis. The commissioner may annually review the list for appropriate updates. The  
1.22 commissioner may contract with a vendor for these duties.

1.23 Subd. 3. **Obtaining and storing epinephrine auto-injectors.** (a) Notwithstanding  
1.24 section 151.37, an authorized entity may obtain and possess epinephrine auto-injectors

2.1 to be maintained and administered to an individual if, in good faith, it is believed that  
2.2 the individual is experiencing anaphylaxis regardless of whether the individual has a  
2.3 prescription for an epinephrine auto-injector. The administration of an epinephrine  
2.4 auto-injector in accordance with this section is not the practice of medicine.

2.5 (b) Epinephrine auto-injectors possessed by an authorized entity shall be stored in  
2.6 a location readily accessible in an emergency and in accordance with the epinephrine  
2.7 auto-injector's instructions for use and any additional requirements that may be established  
2.8 by the commissioner. An authorized entity shall designate employees or agents who  
2.9 have completed the training required in this section to be responsible for the storage,  
2.10 maintenance, and control of epinephrine auto-injectors acquired by the authorized entity.

2.11 (c) An authorized entity may obtain epinephrine auto-injectors from pharmacies  
2.12 licensed as wholesalers pursuant to section 151.44 and may enter into arrangements  
2.13 with manufacturers of epinephrine auto-injectors to obtain epinephrine auto-injectors at  
2.14 fair-market, free, or reduced prices. Prior to an authorized entity obtaining an epinephrine  
2.15 auto-injector, an owner, manager, or otherwise authorized agent of the entity must present  
2.16 to the pharmacy or manufacturer a valid certificate of training obtained pursuant to  
2.17 subdivision 5.

2.18 Subd. 4. **Use of epinephrine auto-injectors.** (a) An employee or agent of an  
2.19 authorized entity who has completed the training required by subdivision 5 may use  
2.20 epinephrine auto-injectors obtained pursuant to subdivision 3 to:

2.21 (1) provide an epinephrine auto-injector to any individual or parent, guardian,  
2.22 or caregiver of such individual, who the employee or agent believes, in good faith, is  
2.23 experiencing anaphylaxis, for immediate administration, regardless of whether the  
2.24 individual has a prescription for an epinephrine auto-injector or has previously been  
2.25 diagnosed with an allergy; or

2.26 (2) administer an epinephrine auto-injector to any individual who the employee  
2.27 or agent believes in good faith is experiencing anaphylaxis, regardless of whether the  
2.28 individual has a prescription for an epinephrine auto-injector or has previously been  
2.29 diagnosed with an allergy.

2.30 (b) Nothing in this section shall be construed to require any authorized entity to  
2.31 maintain a stock of epinephrine auto-injectors.

2.32 Subd. 5. **Training.** (a) An employee or agent of an authorized entity must complete  
2.33 an anaphylaxis training program conducted by a nationally recognized organization  
2.34 experienced in training laypersons in emergency health treatment or an entity or individual  
2.35 otherwise approved by the commissioner. The commissioner may approve specific entities

3.1 or individuals to conduct training and classes of entities or individuals to conduct training.

3.2 Training may be conducted online or in person and, at a minimum, shall cover:

3.3 (1) how to recognize signs and symptoms of severe allergic reactions, including  
3.4 anaphylaxis;

3.5 (2) standards and procedures for the storage and administration of an epinephrine  
3.6 auto-injector; and

3.7 (3) emergency follow-up procedures.

3.8 (b) The entity that conducts the training shall issue a certificate to each person  
3.9 who successfully completes the anaphylaxis training program. The commissioner may  
3.10 develop, approve, and disseminate a standard certificate of completion.

3.11 Subd. 6. **Good samaritan protections.** Any act or omission taken pursuant to  
3.12 this section by an authorized entity that possesses and makes available epinephrine  
3.13 auto-injectors and its employees or agents, a pharmacy or manufacturer that dispenses  
3.14 epinephrine auto-injectors to an authorized entity, or an individual or entity that conducts  
3.15 the training described in subdivision 5 is considered "emergency care, advice, or  
3.16 assistance" under section 604A.01.
