1.11	Subd. 2. Literacy proficiency aid. In fiscal year 2013 and later, the Literacy
1.12	proficiency aid for each school is equal to the product of the school's literacy proficiency
1.13	allowance times the number of third grade pupils at the school on October 1 of the previous
1.14	fiscal year. A school's literacy proficiency allowance is equal to the percentage of students
1.15	in each building that meet or exceed proficiency on the third grade reading Minnesota
1.16	Comprehensive Assessment, averaged across the previous three test administrations,

1.22	of students at that school making medium or high growth, under section 120B.299, on
1.23	the fourth grade reading Minnesota Comprehensive Assessment, averaged across the
1.24	previous three test administrations, times \$530.
