1.8	Notwithstanding any other provision of law to the contrary, the rulemaking authority
1.9	of the Pollution Control Agency and the Department of Natural Resources is eliminated.
1.10	The commissioners of the Pollution Control Agency and natural resources may not adopt,
1.11	amend, or repeal rules after the effective date of this section.
1.12	EFFECTIVE DATE. This section is effective the day following final enactment.

1.15	(a) Minnesota Rules, chapters 6100 to 6290, 7000 to 7190, and 9210 expire July 1,
1.16	2021, unless an earlier date is specified under paragraph (b).
1.17	(b) Beginning with the 2017 regular session, the house of representatives and senate
1.18	committees having jurisdiction over environment and natural resources shall review each
1.19	rule chapter cited under paragraph (a). The committees shall recommend to the full
1.20	legislature enactment of all or any part of the rules, together with any recommended
1.21	amendments to the rules. Rules cited under paragraph (a) that are not reviewed under
1.22	this paragraph expire according to paragraph (a). Rules cited under paragraph (a) that
