fund to the commissioner of transportation for: (1) construction and reconstruction of local roads with statewide or regional significance under Minnesota Statutes, section 174.52, subdivision 4, with priority given to projects that will expand the state's ten-ton road system; and (2) grants to assist counties to pay the costs of rural road safety capital improvement projects on county state-aid highways under Minnesota Statutes, section 174.52, subdivision 4a.

Sec. 2. <u>LOCAL BRIDGE REPLACEMENT AND REHABILITATION;</u> APPROPRIATION.

\$200,000,000 is appropriated from the bond proceeds account in the state transportation fund to the commissioner of transportation to match federal money and to replace or rehabilitate local deficient bridges as provided under Minnesota Statutes, section 174.50.

This appropriation is for the actual construction, reconstruction, and improvement of local bridges, including (1) design-build contracts and consultant usage, and (2) the cost of actual payments to landowners for lands acquired for highway rights-of-way, payments to lessees, interest subsidies, and relocation expenses. When awarding grants under this appropriation, the commissioner may establish priorities according to the master bridge priority list.
