2.13	(e) "Family leave" means leave for any of the following purposes:

2.16	(2) bonding with the employee's child during the first 12 months after the child's birth,

Continuing 3.6 supervision by a health care provider includes a period of incapacity that is permanent or 3.7 long term due to a condition for which treatment may not be effective and where the family 3.8 member is not receiving active treatment by a health care provider. 3.9 (k) "Tax imposed under this chapter" means the taxes imposed under sections 290.06, 3.10 290.091, and 290.0921, but excludes the fee under section 290.0922. 3.11 Subd. 3. Nonresidents and part-year residents. For a nonresident or part-year resident, 3.12 the credit must be allocated using the percentage calculated in section 290.06, subdivision 3.13 2c, paragraph (e). 3.14 Subd. 4. Partnerships; multiple owners. Credits granted to a partnership, a limited 3.15 liability company taxed as a partnership, an S corporation, or multiple owners of property 3.16 are passed through to the partners, members, shareholders, or owners, respectively, pro rata 3.17 to each partner, member, shareholder, or owner based on their share of the entity's assets 3.18 or as specially allocated in their organizational documents or any other executed document, 3.19 as of the last day of the taxable year. 3.20 Subd. 5. Carryover. If the credit allowed under subdivision 1 exceeds the tax imposed 3.21 under this chapter, the excess is a credit carryover to each of the five succeeding taxable 3.22 years. The entire amount of the excess unused credit must be carried first to the earliest 3.23 taxable year to which the amount may be carried. The unused portion of the credit must be 3.24 carried to the following taxable year. No credit may be carried to a taxable year more than 3.25 five years after the taxable year in which the credit was earned. 3.26 **EFFECTIVE DATE.** This section is effective for taxable years beginning after December 3.27 31, 2023, and before January 1, 2027. 3.28
