1.4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.5	Section 1. AMERICANS WITH DISABILITIES ACT NOTICE TO BUSINESSES
1.6	WORKING GROUP.
1.7	Subd. 1. Establishment. The Americans with Disabilities Act Notice to Businesses
1.8	Working Group is established to develop recommendations for the provision to certain
1.9	business owners who file building renovation, remodeling, or structural change plans with
1.10	municipal building officials of notice of whether and to what extent the building and any
1.11	environs owned, managed, or otherwise within the control or legal responsibility of the
1.12	building owner are in compliance with accessibility requirements under the Americans with
1.13	Disabilities Act, the Minnesota Human Rights Act, and relevant state building codes.
1.14	Subd. 2. Working group. (a) The working group shall consist of 13 members as follows:
1.15	(1) the commissioner of human rights or the commissioner's designee;
1.16	(2) the executive director of the Minnesota State Council on Disability or the executive
1.17	director's designee;
1.18	(3) one member appointed by the Association of Minnesota Building Officials;
1.19	(4) one member appointed by the League of Minnesota Cities;
1.20	(5) one member appointed by the Association of Minnesota Counties;

2.15	(1) the content, form, and timing of the notice of whether and to what extent the building
2.16	and any environs owned, managed, or otherwise within the control or legal responsibility

2.24	and are not reimbursed for expenses.
2.25	Subd. 6. Meetings. The working group shall meet once per month for three months and
2.26	thereafter as necessary and at the call of the chair. Meetings of the working group are subject
2.27	to Minnesota Statutes, chapter 13D.
2.28	Subd. 7. Appointments; first meeting. Appointments to the working group must be
2.29	made by June 1, 2017. The commissioner of labor and industry shall convene the first
2.30	meeting by July 15, 2017.

Subd. 8. Report to legislature. By January 15, 2018, the commissioner of labor and industry shall submit a report detailing the working group's findings and recommendations to the chairs and ranking minority members of the senate and house of representatives committees with jurisdiction over civil law and judiciary policy and finance. The report must include any draft legislation necessary to implement the recommendations of the working group.
