3.16	(3) how the business will build on existing regional, national, and international
3.17	strengths to diversify the state's economy;
3.18	(4) whether the business activity would occur without financial assistance;
3.19	(5) whether the business is unable to expand at an existing Minnesota operation
3.20	due to facility or land limitations;
3.21	(6) whether the business has viable location options outside Minnesota;
3.22	(7) the effect of financial assistance on industry competitors in Minnesota;
3.23	(8) financial contributions to the project made by local governments; and
3.24	(9) whether the business location is accessible by public transportation;
3.25	(10) whether the business expansion or location will provide jobs to employees
3.26	from communities of color and employees that receive financial assistance in the form of
3.27	employment and training services as defined in section 116L.19, subdivision 4;
3.28	(11) whether the business will be located at a site that has been remediated or
3.29	redeveloped under sections 116J.551 to 116J.557, 116J.559, or 116J.575 to 116J.5764; and
3.30	(12) any other criteria the commissioner deems necessary.
3.31	(c) Upon receiving notification of local approval under subdivision 2, the
3.32	commissioner shall review the determination by the local government and consider the
3.33	conditions listed in paragraphs (a) and (b) to determine whether it is in the best interests of
3.34	the state and local area to designate a business as a Minnesota job creation fund business.

- (d) If the commissioner designates a business as a Minnesota job creation fund
 business, the business subsidy agreement shall include the performance outcome
 commitments and the expected financial value of any Minnesota job creation fund benefits.
 (e) The commissioner may amend an agreement once, upon request of a local
 government on behalf of a business, only if the performance is expected to exceed
 thresholds stated in the original agreement.
- 4.7 (f) A business may apply to be designated as a Minnesota job creation fund business4.8 at the same location more than once only if all goals under a previous Minnesota job
- 4.9 creation fund agreement have been met and the agreement is completed.
