.5	Section 1. CYRUS AND MORRIS SCHOOL DISTRICT CONSOLIDATION.
.6	Subdivision 1. Purpose. The legislature finds that an orderly, voluntary
.7	consolidation of Independent School Districts Nos. 611, Cyrus, and 769, Morris, promotes
.8	the well-being of the students and increases educational efficiency in those school districts.
.9	Subd. 2. Remediation costs. Independent School District No. 611, Cyrus, may
.10	identify all health and safety remediation costs related to the demolition of the Cyrus
.11	school building and submit those amounts to the commissioner of education for approval.
.12	Any approved costs may be included either in the district's health and safety plan or in the
.13	bonding authority authorized under subdivision 3.
