## 1.4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.5 Section 1. Minnesota Statutes 2013 Supplement, section 340A.301, subdivision 6d,
1.6 is amended to read:

Subd. 6d. Small brewer license. (a) A brewer licensed under subdivision 6, clause 1.7 (c), (i), or (j), may be issued a license by a municipality for off-sale of malt liquor at its 1.8 licensed premises that has been produced and packaged by the brewer. The license must be 19 approved by the commissioner. The amount of malt liquor sold at off-sale may not exceed 1.10 500 barrels annually. Off-sale of malt liquor shall be limited to the legal hours for off-sale at 1.11 exclusive liquor stores in the jurisdiction in which the brewer is located, and the malt liquor 1.12 sold off-sale must be removed from the premises before the applicable off-sale closing time 1.13 at exclusive liquor stores, except that off-sale liquors may be sold by a small brewer on 1.14 Sundays. Sunday sales must be approved by the licensing jurisdiction, and hours may be 1.15 established by those jurisdictions. The malt liquor shall be packed in 64-ounce containers 1 16 commonly known as "growlers" or in 750 milliliter bottles. The containers or bottles shall 1.17 bear a twist-type closure, cork, stopper, or plug. At the time of the sale, a paper or plastic 1.18 adhesive band, strip, or sleeve shall be applied to the container or bottle and extended over 1.19 the top of the twist-type closure, cork, stopper, or plug forming a seal that must be broken 1.20 upon opening of the container or bottle. The adhesive band, strip, or sleeve shall bear the 1.21 name and address of the brewer. The containers or bottles shall be identified as malt 1.22 liquor, contain the name of the malt liquor, bear the name and address of the brewer selling 1.23
