1.4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.5	Section 1. Minnesota Statutes 2016, section 190.11, is amended to read:
1.6	190.11 CAMP GROUNDS AND MILITARY RESERVATIONS.
1.7	(a) The adjutant general shall have charge of the Military Department, camp grounds,
1.8	and military reservations of the state and shall be responsible for the:
1.9	(1) their operation, protection, and safety thereof, and promulgate;
1.10	(2) the promulgation of rules for the their maintenance of order thereon, for;
1.11	(3) the enforcement of traffic rules on camp grounds and military reservations of the
1.12	state; and for
1.13	(4) all other lawful rules as may be ordered for the operation, care, and preservation of
1.14	existing facilities and installations on all state military reservations.
1.15	(b) The authority granted to the adjutant general under this section supersedes any local
1.16	ordinance or rule concerning the same or similar subject matters. State and other
1.17	governmental agencies shall enforce any applicable legal requirements on camp grounds
1.18	and military reservations of the state, including any environmental protection standards
1.19	required under state law.
1.20	(c) The adjutant general shall keep in repair all state buildings, and other improvements
