1.1 A bill for an act
1.2 relating to motor vehicles; establishing C-130 air ready reserve special license
1.3 plates; proposing coding for new law in Minnesota Statutes, chapter 168.

1.4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.5 Section 1. **[168.1254] C-130 AIR READY RESERVE SPECIAL PLATES.**

1.6 Subdivision 1. General requirements and procedures. The commissioner must issue
1.7 C-130 air ready reserve special license plates or a single motorcycle plate to an applicant
1.8 who:

1.9 (1) is a registered owner of a passenger automobile, noncommercial one-ton pickup
1.10 truck, motorcycle, or recreational motor vehicle;

1.11 (2) is a current or former member of the 934th Airlift Wing of the Air Force Ready
1.12 Reserve or the 133rd Airlift Wing of the Minnesota Air National Guard;

1.13 (3) pays a fee in the amount specified for special plates under section 168.12, subdivision
1.14 5;

1.15 (4) pays the registration tax as required under section 168.013, along with any other fees
1.16 required by this chapter; and

1.17 (5) complies with this chapter and rules governing registration of motor vehicles and
1.18 licensing of drivers.

1.19 Subd. 2. Plate design. Representatives from the 934th Airlift Wing of the Air Force
1.20 Ready Reserve and the 133rd Airlift Wing of the Minnesota Air National Guard must design
1.21 the special plate, subject to approval by the commissioner.

2.1 Subd. 3. **Plates transfer.** On application to the commissioner and payment of a transfer
2.2 fee of \$5, special plates issued under this section may be transferred to another motor vehicle
2.3 if the subsequent vehicle is:

2.4 (1) qualified under subdivision 1, clause (1), to bear the special plates; and

2.5 (2) registered to the same individual to whom the special plates were originally issued.

2.6 Subd. 4. **Exemption.** Special plates issued under this section are not subject to section
2.7 168.1293, subdivision 2.

2.8 **EFFECTIVE DATE.** This section is effective January 1, 2021, for C-130 air ready
2.9 reserve special license plates issued on or after that date.
