BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. Laws 2017, chapter 13, article 1, section 15, as amended by Laws 2017, First Special Session chapter 6, article 5, section 10, and Laws 2019, First Special Session chapter 9, article 8, section 19, is amended to read:

Sec. 15. MINNESOTA PREMIUM SECURITY PLAN FUNDING.

- (a) The Minnesota Comprehensive Health Association shall fund the operational and administrative costs and reinsurance payments of the Minnesota security plan and association using the following amounts deposited in the premium security plan account in Minnesota Statutes, section 62E.25, subdivision 1, in the following order:
- 1.13 (1) any federal funding available;
- 1.14 (2) funds deposited under article 1, sections 12 and 13;
- 1.15 (3) any state funds from the health care access fund; and
- 1.16 (4) any state funds from the general fund.
- 1.17 (b) The association shall transfer from the premium security plan account any remaining 1.18 state funds not used for the Minnesota premium security plan by June 30, 2023 2024, to the 1.19 commissioner of commerce. Any amount transferred to the commissioner of commerce 1.20 shall be deposited in the health care access fund in Minnesota Statutes, section 16A.724.
