1.8	Subdivision 1. Appropriation. \$200,000,000 is appropriated from the bond proceeds
1.9	fund to the Board of Regents of the University of Minnesota for Higher Education Asset
1.10	Preservation and Replacement (HEAPR), to be spent in accordance with Minnesota Statutes,
1.11	section 135A.046.
1.12	Subd. 2. Bond sale. To provide the money appropriated in this section from the bond
1.13	proceeds fund, the commissioner of management and budget shall sell and issue bonds of
1.14	the state in an amount up to \$200,000,000 in the manner, upon the terms, and with the effect
