15.10 **Sec. 99. Explanation.**

15.12 **Sec. 100. Explanation.**

15.13 This section updates a cross-reference. Minnesota Statutes, section 326B.164, was
15.14 enacted by Laws 2013, chapter 85, article 2, section 22. During statutory editing, the revisor
15.15 renumbered section 326B.164, subdivision 3a, to subdivision 4, and renumbered the
15.16 remaining subdivisions in order. As a result, the reference to section 326B.164, subdivision
15.17 12, should be to subdivision 13.

15.18 **Sec. 101. Explanation.**

15.19 This section updates a cross-reference. Minnesota Statutes, section 326B.164, was
15.20 enacted by Laws 2013, chapter 85, article 2, section 22. During statutory editing, the revisor
15.21 renumbered section 326B.164, subdivision 3a, to subdivision 4, and renumbered the
15.22 remaining subdivisions in order. As a result, the reference to section 326B.164, subdivision
15.23 5, should be to subdivision 6.

15.24 **Sec. 102. Explanation.**

15.25 This amendment corrects a cross-reference. Laws 2023, chapter 47, article 2, section 3,
15.26 consolidated two definitions for "dependent child" found in section 353.01, subdivisions
15.27 15 and 15a, into one definition coded at Minnesota Statutes, section 353.01, subdivision
15.28 15.

16.1 **Sec. 103. Explanation.**

16.2 This amendment corrects a cross-reference. Laws 2023, chapter 47, article 2, section 3,
16.3 consolidated two definitions for "dependent child" found in section 353.01, subdivisions
16.4 15 and 15a, into one definition coded at Minnesota Statutes, section 353.01, subdivision
16.5 15.

16.6 **Sec. 104. Explanation.**

16.7 This section corrects an obsolete cross-reference. Minnesota Statutes, chapter 144D,
16.8 was repealed and replaced with chapter 144G, by Laws 2019, chapter 60. The Department
16.9 of Health was consulted in the preparation of this section.

16.10 **Sec. 105. Explanation.**

16.11 This section removes obsolete language relating to the interest rate earned on security

16.21 "prosecuting attorney" and "judge" are contained in Minnesota Statutes, section 609.221,
16.22 subdivision 6, clauses (4) and (5), not subdivision 2.

16.23 **Sec. 108. Explanation.**

16.24 This section corrects an obsolete reference. Laws 2021, First Special Session chapter
16.25 11, article 9, moved the definition of "correctional facility" from Minnesota Statutes, section
16.26 241.021, subdivision 1, paragraph (f), to subdivision 1i.

17.1 **Sec. 109. Explanation.**

17.2 This section corrects an incomplete cross-reference. The reference to Minnesota Statutes,
17.3 section 609.749, subdivision 2, clause (8), should include a paragraph. The correct reference
17.4 is to Minnesota Statutes, section 609.749, subdivision 2, paragraph (c), clause (8).

17.5 **Sec. 110. Explanation.**

17.6 This section corrects an erroneous cross-reference. A mental health professional giving
17.7 notice to a sheriff is provided for in Minnesota Statutes, section 624.7171, subdivision 5,
17.8 not Minnesota Statutes, section 626.7171, subdivision 5. There is no Minnesota Statutes,
17.9 section 626.7171.

17.10 **Sec. 111. Explanation.**

17.11 This amendment corrects a cross-reference. When coding Minnesota Statutes, section
17.12 136A.1465, the subdivision numbers assigned in Laws 2023, chapter 41, article 2, section
17.13 19, were reordered. This section updates the cross-reference to the correct subdivision in
17.14 Minnesota Statutes.

17.15 **Sec. 112. Explanation.**

17.16 This section corrects a drafting error that resulted in an erroneous range reference. There
17.17 is no Minnesota Statutes, section 64J.845, nor is there a chapter 64J. The correct
17.18 cross-reference should be to Minnesota Statutes, section 62J.95, which conforms with
17.19 legislation (2023 H.F. No. 17/ S.F. No. 168), referred to conference committee and included

17.28 2934, article 3, section 3.

18.1 Sec. 115. **Explanation.**

18.2 Subdivision 1. **Conflict resolution.** This section resolves a conflict between two enacted
18.3 laws. Laws 2023, chapter 53, article 11, section 31, amended Minnesota Statutes, section
18.4 181.9413, relating to sick leave benefits for the care of relatives. This section was also
18.5 repealed by Laws 2023, chapter 53, article 12, section 8. The repeal was printed in the main
18.6 text and the amendment was printed as a note. This repealer allows the revisor to remove
18.7 the note.

18.8 Subd. 2. **Conflict resolution.** This section resolves a conflict between two enacted laws.
18.9 Laws 2023, chapter 55, article 1, section 2, proposed a new section, Minnesota Statutes,
18.10 section 121A.224, requiring opiate antagonists in schools, and specifically requiring each
18.11 school building to have "two doses of nasal naloxone" available on site. The later enacted
18.12 Laws 2023, chapter 61, article 5, section 1, proposed a similar section with language that
18.13 requires each school building to have "at least two doses of a nasal opiate antagonist"
18.14 available on site. Because the two laws could not be merged editorially, the later enacted
18.15 section was printed in the main text of Minnesota Statutes, section 122A.224, and the
18.16 language from Laws 2023, chapter 55, article 1, section 2, was printed as a note. This repealer
18.17 allows the revisor to remove the note.

18.18 Subd. 3. **Conflict resolution.** This section resolves a conflict between two enacted laws.
18.19 Laws 2023, chapter 55, article 2, section 54, amended Minnesota Statutes, section 124D.68,
18.20 by adding language to include a pupil with a disability as an eligible pupil under subdivision
18.21 2, paragraph (a), and establishing additional eligibility qualifications under paragraph (b).
18.22 Laws 2023, chapter 55, article 7, section 6, amended the same section by only making
18.23 changes to paragraph (b) to include a pupil with a disability as an eligible pupil. Because
18.24 the two sections could not be merged editorially, Laws 2023, chapter 55, article 2, section
18.25 54, which made more detailed changes, was printed in the main text of Minnesota Statutes,
18.26 section 124D.68, subdivision 2, and the language from article 7, section 6, was printed as
18.27 a note. This repealer allows the revisor to remove the note.

18.28 Subd. 4. **Conflict resolution.** This section resolves a conflict between two enacted laws.
18.29 Laws 2023, chapter 16, section 36, amended Minnesota Statutes, section 260.835, subdivision
18.30 2, relating to the expiration of the American Indian Child Welfare Advisory Council. This
18.31 subdivision was also repealed by Laws 2023, chapter 50, article 1, section 38. The repeal
18.32 was printed in the main text and the amendment was printed as a note. This repealer allows
18.33 the revisor to remove the note.

19.1 Subd. 5. **Conflict resolution.** This section resolves a conflict between two enacted laws.
19.2 Laws 2023, chapter 57, article 2, section 39, amended Minnesota Statutes, section 62K.10,
19.3 subdivision 4, relating to insurance provider network adequacy. This subdivision was also
19.4 amended by Laws 2023, chapter 70, article 2, section 22. The amendment in Laws 2023,
19.5 chapter 70, included language in the effective date that superseded the change made in Laws
19.6 2023, chapter 57, article 2, section 39. The changes made by Laws 2023, chapter 70, were
19.7 printed in the main text and the amendment from Laws 2023, chapter 57, were printed as
19.8 a note. This repealer allows the revisor to remove the note.

19.9 Subd. 6. **Conflict resolution.** This section resolves a conflict between two enacted laws.
19.10 Laws 2023, chapter 60, article 7, section 8, amended Minnesota Statutes, section 35.156,
19.11 subdivision 2, relating to the federal funds account for chronic wasting disease. This
19.12 subdivision was also repealed by Laws 2023, chapter 42, article 2, section 142. The repeal
19.13 was printed in the main text and the amendment was printed as a note. This repealer allows
19.14 the revisor to remove the note.

19.15 Subd. 7. **Obsolete subdivision.** This amendment repeals an obsolete subdivision.
19.16 Minnesota Statutes, section 13.6435, subdivision 8, provided a data practices cross-reference
19.17 to financial and production data maintained under Minnesota Statutes, section 32D.25,
19.18 subdivision 2. Laws 2023, chapter 43, article 2, section 142, repealed Minnesota Statutes,
19.19 section 32D.25.

19.20 Subd. 8. **Obsolete provisions.** (a) Paragraph (a) removes an obsolete subdivision.
19.21 Minnesota Statutes, section 273.11, subdivision 16, applies to improvements to homestead
19.22 property made before January 2, 2003. This paragraph was included at the request of the
19.23 House Research Department.

19.24 (b) Paragraph (b) removes an obsolete section. Minnesota Statutes, section 16A.727 is
19.25 obsolete because the commissioner of management and budget has certified that the bonds
19.26 authorized under Minnesota Statutes, section 16A.965, are no longer outstanding as provided
19.27 by Laws 2023, chapter 64, article 13, section 18, the effective date.

19.28 (c) Paragraph (c) removes an obsolete subdivision. Minnesota Statutes, section 297A.71,
19.29 subdivision 45, applied to purchases made before July 1, 2019, according to Laws 2013,
19.30 chapter 143, article 8, section 37, the effective date, as amended by Laws 2014, chapter
19.31 308, article 3, section 33.

19.32 Subd. 9. **Conflict resolution.** This subdivision resolves a conflict between two enacted
19.33 laws. Laws 2023, chapter 63, article 7, section 3, amended Minnesota Statutes, section
19.34 340A.412, subdivision 14, to permit the sale of "edible cannabinoid products as defined in

20.1 section 151.72, subdivision 1, paragraph (f)." Article 6, section 52, of the same law also
20.2 amended Minnesota Statutes, section 340A.412, subdivision 14, to permit the sale of
20.3 "lower-potency hemp edibles as defined in section 342.01, subdivision 50." The article 7
20.4 amendment was effective the day following final enactment while the article 6 amendment
20.5 was effective March 1, 2025. The law did not, however, prospectively repeal or expire the
20.6 article 7 amendment. Because the two amendments are technically mergeable and the article
20.7 7 amendment is not repealed or expired, beginning March 1, 2025, Minnesota Statutes,
20.8 section 340A.412, subdivision 14, would permit the sale of both "edible cannabinoid
20.9 products" *and* "lower-potency hemp edibles." This was not the legislative intent, which was
20.10 to replace the sale of one with the other; not permit the sale of both. By repealing the article
20.11 7 amendment, effective March 1, 2025, the authority to sell "edible cannabinoid products"
20.12 terminates, consistent with legislative intent, and only the sale of "lower-potency hemp

20.14 Subd. 10. **Conflict resolution.** This subdivision resolves a conflict between two enacted
20.15 laws. Laws 2023, chapter 63, article 7, section 1, amended Minnesota Statutes, section
20.16 34A.01, subdivision 4, to clarify that "edible cannabinoid products as defined in section
20.17 151.72, subdivision 1, paragraph (f)" are not included in the definition of "food." Article 6,
20.18 section 6, of the same law also amended Minnesota Statutes, section 34A.01, subdivision
20.19 4, to clarify that "edible cannabis products, as defined in section 342.01, subdivision 20,
20.20 lower-potency hemp edibles as defined in section 342.01, subdivision 50, and hemp-derived
20.21 consumer products, as defined in section 342.01, subdivision 37, that are intended to be
20.22 eaten or consumed as a beverage," are not "food." The article 7 amendment was effective
20.23 the day following final enactment while the article 6 amendment was effective March 1,
20.24 2025. The law did not, however, prospectively repeal or expire the article 7 amendment.
20.25 Because the two amendments are technically mergeable and the article 7 amendment is not
20.26 repealed or expired, beginning March 1, 2025, the definition of "food" in Minnesota Statutes,
20.27 section 34A.01, subdivision 4, would exclude "edible cannabinoid products" *and* "edible
20.28 cannabis products, as defined in section 342.01, subdivision 20, lower-potency hemp edibles
20.29 as defined in section 342.01, subdivision 50, and hemp-derived consumer products, as
20.30 defined in section 342.01, subdivision 37, that are intended to be eaten or consumed as a
20.31 beverage." This was not the legislative intent, which was to replace the exclusion of one
20.32 with the other; not include both. By repealing the article 7 amendment, effective March 1,
20.33 2025, "edible cannabinoid products" will no longer be included in the definition of what is
20.34 or is not "food," under Minnesota Statutes, section 34A.01, subdivision 4, consistent with
20.35 legislative intent.

21.1 Subd. 11. **Expired report.** This subdivision repeals a subdivision containing a report
21.2 that expired by its own terms, on January 1, 2024.
