1.4	Section 1. PRIVATE SALE OF SURPLUS STATE LAND; GOODHUE COUNTY.
1.5	(a) Notwithstanding Minnesota Statutes, sections 94.09 and 94.10, the commissioner
1.6	of natural resources shall sell by private sale the surplus land that is described in paragraph
1.7	(c) to an adjacent landowner.
1.8	(b) The conveyance must be in a form approved by the attorney general. The
1.9	attorney general may make necessary changes to the legal description to correct errors
1.10	and ensure accuracy.
1.11	(c) The land that shall be sold is located in Goodhue County and is described as:
